I have reviewed Tay's pre-construction survey report and it is consistent with the project's mitigation measures. Please keep us updated on any response from CDFW regarding the woodrat houses.

On the second page of the report under "Measure 2b Nesting Bird Survey Results" it looks like there is a typo on the date of the nesting bird survey. I would recommend that you have Tay update the date to reflect the date of the survey to reflect the August survey date (it currently states July 16, 2019).

When you get a chance, can you please confirm the schedule for the upcoming BMP installation and construction start date? It is my understanding that this preconstruction survey was conducted for the BMP installation activities only as no grading permits have been issued.
