Gross earnings for the month ending August 31, 2017 were 1.35%. The current average maturity of the portfolio is .96 years with an average duration of .93 years. The current par value of the pool is \$4.490 Billion. The largest non-government aggregate position is currently Swedbank 3.34%. The portfolio continues to hold no derivative products.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.






San Mateo County Treasurer - Credit Quality


