

The following are the gross pool earnings for fiscal year 2013-2014:

Month End (June)	.87%
4 <sup>th</sup> Quarter (April-June)	.72%
Fiscal Year End 2013-2014	.74%

The current average maturity of the portfolio is 1.71 years with an average duration of 1.67 years. The current par value of the pool is \$3.558 Billion. The largest non-government aggregate position currently held in the pool as of fiscal year end is Union Bank NA at 2.95%. The portfolio holds no derivative products.

The anticipated pool earnings for fiscal year 2014-2015 should be approximately at .65-.75%.

As a reminder, per the 2014 Investment Policy Section XIII Letter G: Effective July 1, 2014, the 3-pool accounting methodology will be eliminated. The County Pool will be operated as a single investment pool.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.







# Monthly Yield Curve




