Extension of Sewer Service by the City of San Carlos to 28 Camborne

(Lands of Lombardo)

Your Commission received a March 8, 2005 report requesting that the Commission delegate approval authority to the Executive Officer for City of San Carlos extension of sewer to the above noted property, because at the time of the writing of the report, it was understood that the City had not yet taken action. The City has since sent a copy of the Council resolution requesting LAFCo approval of the extension of sewer to the property which was adopted on February 14, 2005.

Staff therefore recommends that the Commission approve the request to extend sewer to the 28 Camborne to allow immediate replacement of a failing septic system with public sewer. As noted in the March 8, 2005 report, the extension of sewer is exempt from the California Environmental Quality Act (CEQA). Upon approval by the Commission, staff will send a letter to the City and the property owner authorizing the agreement.
