LAFCo File No. 00-14--Proposed Reorganization of the East Palo Alto County Waterworks District, dissolving the district and transferring service to the Cities of East Palo Alto and Menlo Park

### Summary

This proposal was filed by resolution of the City of East Palo Alto and requests dissolution of the East Palo Alto County Waterworks District (EPACWD) and transfer of service responsibility to the Cities of East Palo Alto and Menlo Park for territory within each city's boundaries. As an application submitted and accepted in 2000, it is subject to the laws of the Cortese Knox Act of 1985. Approval is recommended.

# Departmental Reports

<u>County Assessor</u>: The net assessed valuation shown in the records of the County Assessor is \$829,408,097. The boundaries of the proposal conform to lines of assessment and ownership.

County Clerk: The territory has 5,927 registered voters. The proposal would not conflict with any political subdivision boundaries.

Public Works, Drafting Services: The present jurisdiction of East Palo Alto County Waterworks District consists of 1,550 acres. The map and legal description submitted with the proposal satisfy the requirements of the State Board of Equalization. Natural boundaries, drainage basins or other topographical features would not affect and would not be affected by this proposal.

# San Mateo County Public Works:

The Bay Area Water Users Association (BAWUA) is lobbying the San Francisco Public Utilities Commission to improve the water transmission facilities that provide water to member BAWUA agencies, including EPACWD. No matter who the water purveyor is, the cost of wholesale water will increase. The capital improvements for the transmission facilities will either have to be reflected in increased rates for water or paid for by the cities using other funds. The status of the Menlo Business Park water distribution system should be resolved, as it has never been formally dedicated to the EPACWD. The City of East Palo Alto

may need to obtain a permit from the State Department of Health
Services. Reallocation of EPACWD's Hetch Hetchy Water allocation
may also require an agreement with the San Francisco Public
Utilities Commission.

# Environmental Health:

Water service in the area is provided by the City of Menlo Park and several small mutual water companies. Sanitary sewer service is provided by the West Bay Sanitary District and East Palo Alto Sanitary District. The proposal appears to have no adverse environmental health impact.

Recommendation: Approve

Menlo Park Fire Protection District: No Comment

West Bay Sanitary District: No Comment

East Palo Alto Sanitary District: No Comment

Staff Report from City of Menlo Park: The City of Menlo Park has no objection to approval of the proposal conditioned upon dedication of water lines located within Menlo Business Park to the City of Menlo Park and Execution of the Agreement for Dissolution and Assumption of Service between the Cities of Menlo Park and East Palo Alto. Water rates for service provided by Menlo Park will be the same as rates for other customers of the Menlo Park Water District. Rates may be modified from time to time to reflect costs of maintaining the system and rate increases by the SFPUC. The City has a \$0.35/unit water capital surcharge that has been in effect for 10 years. The Menlo Park Council has approved in concept to charge the new water customers an additional 0.35/unit capital charge in addition to the existing capital charge of \$0.35. If terms and conditions are met and the dissolution is approved, the City anticipates assuming service in April 2001. Provision of service to additional territory in Menlo Park will have little effect on service elsewhere as the city already serves adjacent areas.

### Report and Recommendation

By resolution, the City of East Palo Alto requests dissolution of the East Palo Alto County Water District serving portions of East Palo Alto and Menlo Park, and transfer of service to the two

cities for areas within their respective jurisdictional boundaries. The application states that:

The two cities mutually desire to assume ownership of the portions of EPACWD located within each of their respective corporate boundaries. The City of East Palo Alto will use a private water purveyor, California-American Water Company, to operate and maintain its portion of the system and Menlo Park will operate the Menlo Park portion. The transfer of ownership to the Cities of East Palo Alto and Menlo Park will consolidate a small inefficient water district into larger efficient service operations. Lastly, the City of East Palo Alto also desires to make approximately \$10 million in needed facility improvements over the next ten years. California-American Water company will provide the financing for these needed facility improvements (See Exhibit D to application). The proposed transfer will result in improved and enhanced customer service, improved operation and maintenance and stabilized rates. With the exception of the potential for a capital charge, the City of East Palo Alto and California-American do not anticipate any change in rates for the first three years of operation.

The service area of East Palo Alto County Water includes all territory in East Palo Alto (with the exception of areas served by O'Connor Mutual Water Company and Palo Alto Park Mutual Water Company) and the industrial/commercial properties in eastern Menlo Park as well as a school and 14 residences west of U.S. 101. The District's sphere of influence which was adopted by the Commission in 1985 is zero with the plan that water service be transferred to respective cities.

# Proposed Reorganization

The County of San Mateo has long proposed dissolution of EPACWD because it is a small, inefficient water system serving territory located entirely within the boundaries of cities. The reorganization proposal achieves the dissolution of the District and transfers service responsibility to the Cities of East Palo Alto and Menlo Park, eliminating overlapping service boundaries and duplication of service provision within the same territory. The application submitted for this proposal requests that approval be conditioned on a number of events (Exhibit C of the Application). Proposed conditions include:

1. The City of East Palo Alto shall assume ownership of two EPACWD Hetch Hetchy turnout facilities located within the corporate limits of the City of Menlo Park.

- 2. The City of East Palo Alto shall assume the operations and maintenance responsibilities for that portion of EPACWD located within its corporate limits and the two EPACWD Hetch Hetchy turnout facilities located in Menlo Park.
- 3. The City of Menlo Park will assume operation and maintenance responsibilities for that portion of the EPACWD located within its corporate limits, with the exception of the two Hetch Hetchy turnouts.
- 4. Operation and maintenance costs of facilities jointly used by the Cities of East Palo Alto and Menlo Park shall be allocated to the cities in proportion to the actual use of those facilities by the respective water departments of the respective cities.
- 5. The EPACWD fund balance shall be distributed to the two cities in proportion to the percentage of annual revenues generated by the customers located within the corporate limits of the respective cities as allowed by Government Code Sections 56844 and 57450 of the Government Code.
- 6. The Cities of East Palo Alto and Menlo Park shall revise the EPACWD's Hetch Hetchy water allocation in accordance with the 1984 agreement between the Bay Area Water Users Association and the San Francisco Public Utilities Commission.
- 7. The Cities of East Palo Alto and Menlo Park shall execute agreements regarding the proposed Reorganization of EPACWD and said agreement shall contain all of the terms and conditions described in Items 1-4 above.

An additional condition requested by the City of Menlo Park includes:

1. Dedication of the water system serving the Menlo Business Park to the City of Menlo Park.

#### Existing Water Service

EPACWD is a county water district formed in 1961 under Section 55000 of the California Water Code. Governed by the San Mateo County Board of Supervisors, the District is operated by the San Mateo County Public Works Department, which contracts with California-American Water Company to operate and maintain the system including meter reading and customer billing. The Districts owns a corporation yard on Gloria Way in East Palo Alto. Water supply is purchased from the San Francisco Water Department under the terms of a wholesale water supply contract between the County of San Mateo and the San Francisco Water Department. The District provides water to approximately 3,850 customers for commercial and domestic use and fire flow. The EPACWD system includes three water connections to the SFPUC water main with pressure reducing valves and a network of water mains.

The District system has no storage. However, a water supply well is located on Bay Road but not in use due to color and odor in the water. The State Department of Health requires that the District provide a plan to address minimum storage requirements. A master water plan prepared for the County in 1996 identified storage needs for the District to be 3.7 million gallons. Both Cities will need to address these storage requirements and have discussed the possibility of a joint storage facility. East Palo Alto includes a 3.75 million gallon storage facility in its proposed facility improvements (Exhibit D of the application).

### Proposed Service:

The two cities have submitted rate plans. In the case of East Palo Alto, rates are based on current rates of EPACWD with the commitment that they will remain the same for three years with the exception of the potential for a capital charge. Menlo Park's rates are tiered in that unit price for water increase as consumption increases.

Tables A and B show the current and proposed rates for residential and commercial use.

Menlo Park's water rates are tiered rates favoring conservation with the cost per unit going up as consumption rises. Menlo Park indicates that it may charge an additional \$0.35/unit capital charge to customers transferring to Menlo Park water service in order to recoup the capital charge that current customers have been paying for ten years.

Table C displays what monthly residential charges would be based on average residential consumption of 13 Units (Bay Area Water Users Association).

It is anticipated that all suburban retailers purchasing water wholesale from the San Francisco Public Utilities Commission will be facing increased rates as the SFPUC implements much needed capital improvements to the Hetch Hetchy System. The estimate for needed capital improvements is \$2.5 billion. While California American and East Palo Alto do not anticipate rate changes in the next three years, information is not available as to how improvements to the Hetch Hetchy System will impact rates for all Peninsula Customers. It can be noted that whether the operation of the District remains a county function, rates will be impacted for necessary capital improvements.

As stated above, improvements to the East Palo Alto portion of the water system are listed in Exhibit D of the East Palo application. The current estimated value of the improvements is approximately \$10,000,000. California American Water Company, as operator for the City of East Palo Alto anticipates Prop. 13 funding and Federal grants to offset the costs of improvements. The system in the Menlo Park portion of the District is less than twenty years old and no immediate maintenance needs are anticipated.

# Water Allocation of the Dissolved District

The East Palo Alto County Water District is signatory to the 1984 Settlement Agreement and Master Sales Contract with the SFPUC. As part of that agreement the District has entitlement to water allocation from SFPUC. Changes in assignment of the allocation require approval by SFPUC. The City of Menlo Park requests that the allocation associated with the Menlo Park portion of the District be transferred to the City of Menlo Park. Correspondence from the SFPUC indicates that this can only take place if the portion of the system in Menlo Park is separated. It appears that if SFPUC does not agree to transfer the Menlo Park share of the EPACWD allocation at this time, all allocation would be transferred to East Palo Alto and East Palo Alto would act in a trust capacity providing water to customers in Menlo Park until the Menlo Park water system is extended to the area.

### East Palo Alto County Water District Fund Balance

The District's fund balance as of June 30, 2000 was \$1,971,023. The estimated fund balance after paying a loan with the State and account activities when the billing was transferred to California American Water, the current contract operator, is approximately \$1,300,000. Distribution of district assets upon dissolution are governed by Section 56457 or alternatively by any condition of approval set by LAFCo pursuant to Section 56844. The formula for distribution of assets set forth in Section 56457 is based on the assessed value of the territory located in each city. This formula assumes that the fund balance is a function of property tax revenue collected by the District. As an enterprise district, EPACWD's fund balance accumulated as a function of rates paid to the district and not property tax collected. An alternative formula agreed upon by the cities is that distribution of fund balance based on rates paid by customers in the two distinct areas. The District reports that this method would result in a distribution of 90% of the fund balance to East Palo Alto and 10% to the City of Menlo Park.

Section 56463 further directs that funds may be distributed once the necessary expenses of winding up the affairs of the district are paid and that the funds shall be used for the benefit of the affected territory of the dissolved district.

# Successor Agency

Section 57451 provides that for the purpose of winding up the affairs a dissolved district located within the boundaries of two or more cities, the successor agency shall be the city containing the greater assessed value of territory of the district. In this case the City of East Palo Alto is the city with the greater assessed value. As successor agency, the City of East Palo Alto will be responsible for winding up the affairs of the dissolved EPACWD which will include distribution of funds, assets and facilities as directed by Section 57463 and any conditions set by LAFCo.

### Effective Date of Dissolution

Section 57202 specifies that if no effective date is fixed in the terms and conditions of the Commission resolution, the effective date is the date the Certificate of Completion is filed with the County recorder. The certificate of completion can not be filed until all conditions are met and conducting authority proceedings have been completed. In this case, if LAFCo approval is granted at the January 17 meeting, it is recommended that the effective date be April 1, 2001 as the beginning of a new fiscal quarter.

# Execution of Agreements

The two cities agree that, once dissolved, the cities can jointly and efficiently operate the water system in their respective areas. In order to implement joint operation, the two cities have drafted agreements (Operating Agreement and Dissolution, Assignment Assumption Agreement) setting conditions of joint operation and maintenance of shared facilities, ownership of turnout facilities and other related matters. The initial draft Dissolution, Assignment and Assumption Agreement (attached) includes the EPACWD as a party to the agreement. It has since been established that many of the issues addressed in the draft agreement will be determined by provisions of Cortese Knox pertaining to disposition of fund balance and it is not appropriate for the County to be party to the agreement. Also, the two cities will be meeting on January 16 to further discuss terms of the agreement. Among the issues yet to be resolved in drafting the agreements are water allocation and ownership of the Hetch Hetchy turnout facilities. SFPUC has commented that turnout facilities are owned by the SFPUC and water allocation is

determined by SFPUC in addition. It is anticipated that a revised agreement removing the County as party to the agreement and agreed upon by the cities and Operating Agreement will be made available at the Commission meeting. Section 56844 permits the Commission to approve the reorganization conditioned upon execution of agreements by the two cities.

# Conducting Authority Proceedings

Section 56029 designates the Board of Supervisors as conducting authority for proposals for the dissolution of districts. If the proposal is approved, the Board of Supervisors would hold a hearing to measure protest from within the affected area. Section 56839.1 sets forth that dissolution proposals which are not submitted by the Commission and where an affected city or district has not objected by resolution, the Conducting authority can order a dissolution without election if protest is submitted representing less than 25% of the registered voters or less than 25% of the landowners owning 25% of the assessed value in the territory.

#### Recommendation

LAFCo File 00-14 proposing dissolution of EPACWD and transfer of service to the Cities of East Palo Alto and Menlo Park is consistent with the Commission's policies discouraging overlapping boundaries of agencies providing the same services and policies favoring elimination of single, purpose special districts when service can be provided by cities. The proposal is also consistent with the adopted sphere of influence of the district. Dissolution of the District would transfer all assets and obligations to the two cities. In the case of Menlo Park, the city is an existing water retailer with the capacity to maintain and provide customer service to the Menlo Park portion of EPACWD. In the case of East Palo Alto, the City will contract with California-American Water Company, the current contract operator of the District with the ability and resources to provide a municipal level of customer service and maintenance. The proposed agreement between the two cities would govern the joint operation of the water system and provide the opportunity for collaboration in meeting storage facilities needs for areas east of U.S. 101.

Staff recommends approval of the reorganization, subject to the condition that the Cities of East Palo Alto and Menlo Park execute the proposed agreement, dedication of the water system serving the Menlo Business Park to the City of Menlo Park and necessary approvals and permits from the San Francisco Public Utilities Commission and California Department of Health.

Recommended Commission Action, by Resolution: Approve LAFCo File No. 00-14 and authorize the County Board of Supervisors to conduct subsequent proceedings pursuant to Government Code Section 57000 subject to the following conditions:

- 1. Execution of the Dissolution, Assignment and Assumption Agreement and Operating Agreement between the Cities of East Palo Alto and Menlo Park.
- 2. Dedication of the water system serving the Menlo Business Park to the City of Menlo Park.
- 3. Required approval from SFPUC for the dissolution of East Palo Alto County Water District and Transfer of Water Allocation to Successor Agencies.

4. Required permits from California Department of Health Services.

# PLAN FOR PROVIDING SERVICES

1. Enumerate and describe the services to be extended to the affected territory.

Water service currently provided by EPACWD would be provided by the City of East Palo Alto/California-American Water Company and the City of Menlo Park to the portions of the affected territory located within their respective corporate boundaries.

2. Describe the level and range of those services.

The City of East Palo Alto/California-American Water Company and the City of Menlo Park will provide water service for domestic use and fire protection to all property owners and residences located within their respective corporate boundaries of the affected territory. The services will be equal to or better than the water service currently provided.

3. Indicate when those services can feasibly be extended to the affected territory.

Upon the dissolution of EPACWD, the City of East Palo Alto/California-American Water Company and the City of Menlo Park will immediately extend water service to the affected territory. There will be no interruption in service.

4. Indicate any improvements or upgrading of structures, roads, sewer or water facilities, or other conditions to be imposed or required within the affected territory.

Attached as Exhibit D is a list of the facility improvements to be made by the City of East Palo Alto/California-American Water Company within 10 years after the dissolution of EPACWD.

5. Describe financial arrangements for construction and operation of services extended to the affected territory. Will the affected territory be subject to any special taxes, charges or fees? (If so, please specify.)

The City of East Palo Alto will set charges and fees for operation of services. The City of East Palo Alto and California-American Water Company will jointly arrange private financing for the

proposed facility improvements described in Exhibit D. With exception of the creation of a capital charge, the City of East Palo Alto does not anticipate any changes in the existing rate structure for water service for the first three years of operations. The proposed capital charge will pay for the proposed facility improvements described in Exhibit D. The City of Menlo Park will set charges and fees for operation of services and finance future facility improvements.

6. In as much detail as required to give a clear explanation, explain why this proposal is necessary at this time.

The transfer of ownership of the EPACWD to the Cities of East Palo Alto and Menlo Park will consolidate a small inefficient water district into larger efficient water service operations. Notably, the proposed transfer will also result in (a) improved and enhanced customer service; (b) improved system operations and maintenance; and (c) stabilized service rates. The Cities of East Palo Alto and Menlo Park both possess the financial and technical capabilities to make all necessary facility improvements to EPACWD. Lastly, the proposed transfer is consistent with and supports LAFCo's general policy of encouraging service districts that are located within a single political jurisdictional boundary.



# **EXHIBIT C**

# OTHER TERMS AND CONDITIONS REGARDING PROPOSED REORGANIZATION OF EAST PALO ALTO COUNTY WATERWORKS DISTRICT ("EPACWD")

# A. Ownership

- 1. The City of East Palo Alto shall assume ownership of all of the EPACWD assets located within its corporate limits and the two EPACWD Hetch Hetchy turnout facilities located within the corporate limits of the City of Menlo Park.
- 2. With the exception of the two Hetch Hetchy turnout facilities, the City of Menlo Park shall assume ownership of all of the EPACWD assets located within its corporate limits.

# B. Operations and Maintenance

- 1. The City of East Palo Alto shall assume the operations and maintenance responsibilities for that portion of EPACWD located within its corporate limits and the two EPACWD Hetch Hetchy turnout facilities located within the corporate limits of the City of Menlo Park.
- 2. With the exception of the two EPACWD Hetch Hetchy turnout facilities, the City of Menlo Park shall assume the operations and maintenance responsibilities for that portion of EPACWD located within its corporate limits.
- 3. The operations and maintenance costs of facilities jointly used by the Cities of East Palo Alto and Menlo Park shall be allocated to the Cities in proportion to the actual use of those facilities by the respective water departments of the Cities.

# C. Fund Balance

The EPACWD fund balance shall be distributed to the Cities of East Palo Alto and Menlo Park in proportion to the percentage of annual revenues generated by the customers located with in the respective corporate limits of the cities.

# D. <u>Water Allocation</u>

The Cities of East Palo Alto and Menlo Park shall revise EPACWD's Hetch Hetchy water allocation in accordance with the 1984 Agreement between the Bay Area Water Users Association and the San Francisco Public Utilities Commission.

# E. Agreement

The Cities of East Palo Alto and Menlo Park shall execute an agreement regarding the proposed reorganization of EPACWD. This agreement shall contain all of the terms and conditions described above in sections A through D.
