



May 30th Virtual Conversation: Overview Meeting

We heard people would like to see:

- Projects to decrease traffic
- Better solutions for people walking to get across Highway 1
- Continuous sidewalks and bikeways
- The plan address things like evacuation and emergency response, bike share, ondemand transportation, agefriendly improvements, and more



June 15th Virtual Conversation: Montara & Moss Beach Meeting

We heard people are interested in:

- Project phasing what can be implemented in the short-term?
- Neighborhood-level project recommendations that address speeding on residential streets
- Improving street lighting along Highway
 1 while preserving Midcoast character
- Completing the Parallel Trail
- Express and frequent bus service to San Francisco, BART stations, and Half Moon Bay for commuters

Village Zone

Midcoast Parallel Trail

- Multimodal walking and biking trail
- Separated from Highway 1
- Will connect
 Montara, Moss
 Beach, El Granada,
 Miramar and Half
 Moon Bay





Pedestrian Crossing Improvements

- Install crossings across Highway 1, along the Parallel Trail and on neighborhood streets
- Improve existing crossings and add new crossings with high-visibility striping and pedestrian activated beacons







Bus Stop Improvements

- Add benches or shelters
- Add street crossings and sidewalks



Highway 1 Improvements

- Create standardized, safe roadway designs for the "village" and "fringe" zones of Highway 1
- Village Zone: Add curbs and gutters, lane widths less than 12 feet
- Fringe Zone: Add valley gutter





Bike Lanes & Bike Parking

- Add striped bike lanes along Highway 1
- Install bike parking





Signage Improvements

- Improve the safety of intersections and roadways by adding signs for drivers, pedestrians and cyclists
- Add "wayfinding" signs that will help people find important community locations







California Coastal Trail

Complete the Coastal Trail from Montara to Half Moon Bay





Airport Street

Add striped bike lanes, a separated bike trail or other bike safety improvements on Airport Street







Capistrano Road

Widen the shoulders of Capistrano Road and add shared lane markings to create a safer bike route for bike riders.

Sidewalks & Safe Routes to School

- Make it safer and easier for students and families to walk to Wilkinson School and El Granada Elementary School
- Build new sidewalks and crosswalks that will create continuous walking paths on Coronado Street, Obispo Road and Avenue Alhambra



Multipurpose Parking Lot

- Build a parking lot that would encourage commuters to use public transit during the week and provide parking for recreational visitors on weekends
- Include green infrastructure and bicycle parking








Create a parking lot between Highway 1 and Avenue Alhambra

Existing Route HWY 1 Improvements Village Zone




