The Ordinance does not affect regulations pertaining to Residential Full-Time Care Facilities for Children (Group Homes, Foster Family Homes) in the One-Family Residential/Country Club Park (R-1/CCP) Zoning District); and Institutional and/or Residential Full-Time Care Facilities for Children in the General Commercial Districts/North Fair Oaks (C-2/NFO), Institutional/North Fair Oaks District (I/NFO), Planned Colma District (PC), and Residential Hillside District (RH).
