Domestic Violence impact on minors in CA	Presentation	<ul> <li>Goal: to reduce the number of firearms on the streets and to generally speak to gun control.</li> <li>List of people prohibited from possessing firearms or have relinquished their firearms</li> <li>What can we do to enhance Red flag laws?</li> <li>Rather than focus on gun control, focus on gun safety</li> <li>SB 320: requires courts to order firearms relinquishment and control ammunition sales; and follow up.</li> <li>End Result: Re-establishment of a Domestic Violence Firearms Compliance Unit (will be funded now by CEO) – countywide</li> <li>More coordination of mental health professionals and law enforcement</li> <li>Control of ghost guns</li> <li>"How to" attain a domestic violence restraining order written up and needs provided to the DVC</li> <li>Johana Millan, Victims Services Manager, CARE, Office of the Attorney General, State of California</li> <li>Started with Maggie Krell, Special advisor to Attorney General.</li> <li>Johana Millan, El Dorado County District Attorney's Office for almost 30 years.</li> <li>Shared her lived experience as a domestic violence survivor; including the experiences of her children and the services they received.</li> <li>Before looking at a Mandate on mental health, address:</li> <li>Education on the importance of mental health services from a forensic interviewer</li> </ul>

SMC Minors Residing in DV Homes	Update	<ul> <li>Mike Callagy, County Executive Officer</li> <li>When youth experience DV in a family and they then turn into abusers.</li> <li>Spoke to state legislators about statewide bill that would mandate counseling for dv survivor children and their names would be processed with intake – sent to Victim Services. Children would then receive mental health counseling.</li> <li>Process is late for this legislative session.</li> <li>Plenary stage, talking more about process and how it would work. SMC would be a pilot program.</li> <li>SMC would possibly be the first in the state to do this</li> </ul>
