Since my most recent noise complaint on May 17, you may not realize that we in the San Mateo Highlands neighborhood have continued to suffer having to listen to the noisy gasoline-powered generator at Lot 11. Even today, as I write this email at 8am on Friday July 8, 2022, I'm sitting in my home office listening to the generator.

On May 18 you wrote that Bob from the Chamberlain Group "has an appt with PG&E today for gas service and anticipates being able to connect to electricity within 1 week – then no more generator".

Once again, this latest estimate has turned out not to be true.

As you know, we in the Highlands neighborhood have been complaining about the Lot 11 construction noise since 2020. I'm glad to hear that for the proposed construction of four additional houses on Lots 5-8, the County has acknowledged our complaints by having the Chamberlain Group agree to get a temporary power pole to eliminate the need for noisy generators.

Meanwhile, what is the latest status with PG&E regarding an electrical connection for Lot 11?

Good morning.

It sounds like what you're saying is rather than cover the cost to rent the appropriate and street-legal vehicle to transport this gravel and dirt between the lots - one time - the builder instead repurposed an excavator and used it as an inefficient hauler. Instead of a street-legal dump truck, they used the excavator shovel to transport shovelfuls of gravel and dirt, bit by bit over many hours, nonstop between the lots, back and forth across in front of our homes. Perhaps they already had an excavator and a laborer onsite and it was more expedient - for them - to do it this way. This sounds like corner-cutting by the builder, outside of the realm of accepted best practices, and possibly not even legal, to benefit their bottom line at the public's expense. The neighborhood has to incur this cost — undue wear and tear to the road, debilitating excessive and constant noise, loss of enjoyment, increased safety vigilance, safety risk, and strong potential of gravel and rock damage to our parked cars. And we're expected to believe this is OK just because it didn't take place "outside of the allowed construction hours"?

I did not see brake lights, headlights, turn signal, license plate, or guide car. Half of the several dozen trips were done backwards without alert sounds. I do not believe this was even legal activity.

The county had no idea this was happening because there was no monitoring except from the public itself.

He is now done with the bioretention basins. He wont be storing any more materials on other lots and therefore

won't need to go back-and-forth like he was. I asked him to comply with the construction hours and he says he has. The houses are nearing completion. Thank you for your patience.

Thanks for your feedback regarding Saturday work hours. Specifically, **NOI 1.3** (construction hours) says (bold added for emphasis):

The grading and construction activity would be kept to the hours of 7:00 AM to 7:00 PM, Monday through Friday. Saturday hours (8:00 AM to 5:00 PM) are permitted upon the discretion of County approval based on input from nearby residents and businesses. **Saturday construction (8:00 AM to 5:00 PM) would be allowed once the buildings are fully enclosed.** Noise generating grading and construction activities shall not occur at any time on Sundays, Thanksgiving and Christmas.

In speaking with the Superintendent, the need for the generator last Saturday was unanticipated. I was able to obtain more information. While the Superintendent scheduled the work on Saturday, as permitted by NOI 1.3, he did not anticipate the subcontractor's use of the pneumatic nail gun (which needed the use of the generator), as the County's Nailing Inspection for the Lath was already completed and passed. The subcontractor was finishing up some loose ends. As the Superintendent was not present at the site, this took him by surprise as well. As he stated to me last week, he will not be running the generator on Saturdays until the job is complete.

We appreciate your patience and will continue to try to work together the best we can until this project is completed.

Thanks for following up and for gathering this information. Some information you've received may not be accurate, because the generator is not in the garage, it's in the front yard. You can see it in the YouTube video I provided below. Here's the link again <a href="https://youtu.be/5TzbWakYRCs">https://youtu.be/5TzbWakYRCs</a>. The date of this video is Saturday May 8.

NOI-1.3 says: "construction activity would be kept to the hours of 7:00 AM to 7:00 PM, Monday through Friday. Saturday hours (8:00 AM to 5:00 PM) are permitted upon the discretion of County approval based on input from nearby residents". The County did not ask for input from me or from other nearby residents regarding the Saturday work hours (and in general my neighbors and I do not approve of the Saturday work hours). If the County has permitted Saturday work hours without asking for input from nearby residents, isn't that a violation of NOI-1.3?

I spoke with Jessie and Bob today and this is what I learned. Regarding use of generators and NOI 1.2 (use of electrically powered equipment), generators are needed as PG&E service is extremely delayed; unfortunately, the houses are likely going to be connected to electricity just prior to final of the building permits. Bob has done as much as he could to get the houses to get connected earlier.

The generator that is being run now is the stucco subcontractor's generator; stucco will likely be done this week. The plastic needed to contain stucco drips in the backyard prevents the generator from also being located in the backyard, as workers could be asphyxiated by generator fumes. Therefore, the generator is located for now in the garage.

After the stucco is completed, Bob will still need a generator but it will be located in

the backyard again.

Regarding NOI 1.3 (construction hours), Bob said that last Saturday, he was not onsite, and workers may have used the radio or the generator. He said that he has asked the workers not to use their radio and he says he will not be running the generator on Saturdays until the job is complete. Construction should be completed by the end of the month.

Hello Bob and Camille,

I'm writing to complain about the construction noise from the new house construction project on Lot 11 in the San Mateo Highlands, next to my house at 2067 New Brunswick Drive. My family has endured five months of construction noise so far, which has been particularly painful due to the

Covid-19 pandemic, since my wife and I are both working from home, and both of my children are attending school online at home.

At this point, the noise of the gasoline-powered generator used by the construction crew day after day has become unacceptable. This video link will give you an idea of how loud it is: <a href="https://youtu.be/6zACU6BQY-U">https://youtu.be/6zACU6BQY-U</a>. Every day. While my kids are trying to attend school.

This past Saturday I spoke in person onsite with Bob about the noise. He indicated it may be months before Nexgen Builders are able to run a power line from the nearest utility pole, so he suggested in the meantime moving the generator to the back of the house, which should decrease the noise level. Today is Thursday, and the generator has not been moved.

The Highlands Estates project conditions of approval document contains the following items:

Mitigation Measure NOI-1:

The Project Applicant shall require that the following noise reduction practices be implemented by including them in the contractor construction documents:

- 1. Equipment and trucks used for project grading and construction would utilize the best available noise control techniques (e.g. improved exhaust mufflers, equipment redesign, use of intake silencers, ducts, engine enclosures, and acoustically-attenuating shields or shrouds) in order to minimize construction noise impacts.
- 2. Equipment used for project grading and construction would be hydraulically or electrically powered impact tools (e.g. jack hammers and pavement breakers) wherever possible to avoid noise associated with compressed air exhaust from pneumatically—powered tools. Compressed air exhaust silencers would be used on other equipment. Other quieter procedures would be used such as drilling rather than impact equipment whenever feasible.
- 3. The grading and construction activity would be kept to the hours of 7:00 AM to 7:00 PM, Monday through Friday. Saturday hours (8:00 AM to 5:00 PM) are permitted upon the discretion of County approval based on input from nearby residents and businesses. Saturday construction (8:00 AM to 5:00 PM) would be allowed once the buildings are fully enclosed. Noise generating grading and construction activities shall not occur at any time on Sundays, Thanksgiving, and Christmas.

4. Residential property owners within 200 feet of planned construction areas shall be notified of the construction schedule in writing, prior to construction; the project sponsor shall designate a "disturbance coordinator" who shall be responsible for responding to any local complaints regarding construction noise; the coordinator (who may be an employee of the developer or general contractor) shall determine the cause of the complaint and shall require that reasonable measures warranted to correct the problem be implemented; a telephone number of the noise disturbance coordinator shall be conspicuously posted at the construction site fence and on the notification sent to neighbors adjacent to the site.
I can prove that each one of these items has been violated. But before we go down that legal road, how about at least moving the gasoline-powered generator to the back of the house.
