#### **RECOMMENDATION:**

Recommendation for appointments to the Commission on the Status of Women:

- A) Julissa Acosta, for an initial full term ending December 31, 2026; and
- B) Susan Takalo, for an initial full term ending December 31, 2026; and
- C) Aysha Pamukcu, for an initial full term ending December 31, 2026; and
- D) Jess Hudson, for an initial partial term ending December 31, 2024; and
- E) La Saundra Gutter, for an initial partial term ending December 31, 2024.

#### BACKGROUND:

The Commission is charged with the responsibility of assessing the needs of women, girls and families in the County. It acts as a resource and makes recommendations to the Board of Supervisors annually.

#### **DISCUSSION**:

Julissa Acosta, Susan Takalo, and Aysha Pamukcu are each being recommended to serve their first full terms on the commission for seats vacated by Christine Padilla, Kelly Keele, and Karen Pyles. Jess Hudson and La Saundra Gutter are each being recommended for existing partial terms ending December 2024 for seats vacated by Dana Linda and Marguerite Machen who have resigned mid-term.

Julissa Acosta was inspired by the 2022 Women's Hall of Fame and decided to apply to the Commission on the Status of Women because of this event. She has lived on the coast and in Half Moon Bay for over 22 years and has found that women of color are usually behind in growth and development opportunities. She would like to provide more representation from the coast on the CSW and also meet others with the same interests and passion.

Susan Takalo has lived on the coast for many years and has recently relocated to Half Moon Bay with her wife. She will be retiring in June of 2023 from Second Harvest Food Bank and looks forward to dedicating more time to empowering women and girls. She also volunteers on the San Mateo County Pride Initiative and is an active member of the San Mateo County Pride Center and CoastPride.

Aysha Pamukcu resides in South San Francisco and is a life-long resident of the County (born in Redwood City). Aysha is the Director of the Policy Fund at the San Francisco Foundation and has seen first-hand how lack of housing has impacted women. She looks forward to working on equity issues and giving back to the San Mateo County community.

Jess Hudson is a resident of Millbrae and a life-long resident of San Mateo County. She has 10 years of lived experience as a low-income single mother who has experienced domestic violence. She currently works for the United Way Bay Area as a Policy Specialist and has passion for issues specific to women and families.

La Saundra Gutter is recently retired after working for the County of San Mateo Youth Services Center, specifically with girls, for most of her career. She and her family live in Pacifica and she is eager to volunteer her time on the Commission on the Status of Women.

#### **RESOLUTION NO.**

#### RESOLUTION FINDING THAT, AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY DECLARED BY GOVERNOR NEWSOM, MEETING IN PERSON FOR MEETINGS OF THE COMMISSION ON THE STATUS OF WOMEN WOULD PRESENT IMMINENT RISKS TO THE HEALTH OR SAFETY OF ATTENDEES

WHEREAS, on March 4, 2020, the Governor proclaimed pursuant to his authority under the California Emergency Services Act, California Government Code section 8625, that a state of emergency exists with regard to a novel coronavirus (a disease now known as COVID-19); and

WHEREAS, on June 4, 2021, the Governor clarified that the "reopening" of California on June 15, 2021 did not include any change to the proclaimed state of emergency or the powers exercised thereunder, and as of the date of this Resolution, neither the Governor nor the Legislature have exercised their respective powers pursuant to California Government Code section 8629 to lift the state of emergency either by proclamation or by concurrent resolution in the state Legislature; and

WHEREAS, on March 17, 2020, Governor Newsom issued Executive Order N-29-20 that suspended the teleconferencing rules set forth in the California Open Meeting law, Government Code section 54950 et seq. (the "Brown Act"), provided certain requirements were met and followed; and

WHEREAS, on September 16, 2021, Governor Newsom signed AB 361 that provides that a legislative body subject to the Brown Act may continue to meet without fully complying with the teleconferencing rules in the Brown Act provided the legislative body determines that meeting in person would present imminent risks to the health or safety of attendees, and further requires that certain findings be made by the legislative body every thirty (30) days; and,

WHEREAS, California Department of Public Health ("CDPH") and the federal Centers for Disease Control and Prevention ("CDC") caution that the Delta variant of COVID-19, currently the dominant strain of COVID-19 in the country, is more transmissible than prior variants of the virus, may cause more severe illness, and that even fully vaccinated individuals can spread the virus to others resulting in rapid and alarming rates of COVID-19 cases and hospitalizations

(https://www.cdc.gov/coronavirus/2019-ncov/variants/delta-variant.html); and,

WHEREAS, the CDC has established a "Community Transmission" metric with 4 tiers designed to reflect a community's COVID-19 case rate and percent positivity; and,

WHEREAS, the County of San Mateo currently has a Community Transmission metric of "substantial" which is the second most serious of the tiers; and,

WHEREAS, the Commission on the Status of Women has an important governmental interest in protecting the health, safety and welfare of those who participate in its meetings; and,

WHEREAS, in the interest of public health and safety, as affected by the emergency caused by the spread of COVID-19, the Commission on the Status of Women deems it necessary to find that meeting in person would present imminent risks

to the health or safety of attendees, and thus intends to invoke the provisions of AB 361 related to teleconferencing;

WHEREAS, The Board of Supervisors strongly encourages all legislative bodies of the County of San Mateo that are subject to the Brown Act, including but not limited to, the Planning Commission, the Assessment Appeals Board, the Civil Service Commission, and all other oversight and advisory boards, committees and commissions established by the Board of Supervisors and subject to the Brown Act, to make a similar finding and avail themselves of teleconferencing until the risk of community transmission has further declined;

#### NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

- 1. The recitals set forth above are true and correct.
- The Commission on the Status of Women finds that meeting in person would present imminent risks to the health or safety of attendees.
- 3. Staff is directed to return no later than thirty (30) days after the adoption of this resolution with an item for the Commission on the Status of Women to consider making the findings required by AB 361 in order to continue meeting under its provisions.
- 4. Staff is directed to take such other necessary or appropriate actions to implement the intent and purposes of this resolution.
