I joined today's zoom meeting towards the end of the session but Al Matin, SBAY Construction President, joined the meeting during the presentation due to some technical difficulties, he could not connect earlier. We would like to make sure we are accounted as a participant to the Mandatory Pre-bid meeting and submit our bid on March 2nd.
- R1. A virtual mandatory informational pre-bid conference will occur on Monday, March 6, 2023 at 10:00 AM. Contractors are only allowed to bid the project if they join the mandatory pre-bid meeting within 10 minutes of the meeting start time and stay for the entire meeting. Contractors who joined the February 23, 2023 pre-bid meeting within 10 minutes of the meeting start time do not need to attend the March 6, 2023 pre-bid meeting.
- Q2. We noticed a Al Matin of SBAy construction joined the mandatory pre-job meeting very late (11:50) after many had signed out. Question: will he be allowed to bid the projects?
