Exhibit 1 shows how the new house on Cowpens Way gets a nicely paved driveway and street. Exhibits 2 and 3 show the resulting messy asphalt tire marks on what used to be a clean street in front of the neighbor's houses on New Brunswick Drive. Exhibit 4 shows an example of the many globs of asphalt on New Brunswick Drive as a result of the paving.

My expectation is that San Mateo County would require Chamberlain Group / NexGen Builders to arrange to have the pavement on New Brunswick Drive scrubbed to a point where it looks similar to its original clean condition before the paving of Cowpens Way. What would be the next step to make this happen?
