### • Exploring Our Roots: Unpacking Bias in Order to Grow

- Olt's human nature to make assumptions about people, identities, and communities. At a glance, we categorize people and place them into boxes frequently unknowingly. Many of our beliefs are often passed on through generations and go unnamed. We move through the world with ongoing assumptions and belief systems unknowingly until space is provided to help bring awareness to our own implicit biases. Thus, the Pride Center is proud to announce a new FREE training, Exploring Our Roots: Unpacking Bias in Order to Grow.
- Supported by the Kaiser Foundation, each training will create a carefully guided training allowing work to begin to unpack our own internalized myths we hold, ask ourselves where they come from, and examine the roots of their inheritance.

### Overview, Last Youth Commission Meeting: Committee Progress, Overall Updates

Overview of Last Commission Meeting:

The Youth Commission was lively last meeting, with increased public engagement, getting a public comment from the Positive Alternative Recreation Team Building Impact (P.A.R.T.I) representative announcing a Stop the Violence Event, Student Led & Run. As we come closer to May 1st more potential youth commissioners come and engage with the youth commission. This past meeting they got the chance to hear a conversation with President Pine and Superintendent Nancy Mcgee discussing Gun Violence within our County and specifically its effect on youth. Overall a phenomenal meeting.

### Update:

### Subcommittees

- Educational Equity continues to work in conjunction with First Five San Mateo on their Diverse Literacy Project. The committee has decided to forgo its original project for this year and set the foundation for its continuation next year. As well as, begin planning another workshop to promote DEI within the county.
- Civic Engagement continues work on its multiple projects, with a voter engagement event set for April 23rd. As well as the beginnings of a voter engagement website.
- Immigrant Youth, continues to work on preparation for the launching of this year's Immigrant Youth Scholarship(more news to come). As well as outreach on redcards to pass out within the community.
- Health & Wellness, continues with plans for their mental health walks event, with the possible date being April 8th (subject to change)
- Environmental Justice has reached out to its speakers and set a date for its annual symposium, settling on April 8th 3-4pm. The committee also begins research on the coast's water quality, having conversations with community members and experts.
- The Juvenile Justice Workgroup continues to work on its resolution with a plan to present it to the youth commission in April. Their resolution centers around making sure no Youth in the county is tried as an adult. With a possible second resolution to

assist youth in reporting issues they're facing.

- Commission Outreach
  - O In our last meeting our Commission Outreach Coordinators (Social Media Coordinators) announced a feature in San Mateo High School's career fair, with both Chloe & I getting the opportunity to table that event this past Tuesday.
  - The Coordinators continue to run the Youth Commission's Social Media, and have announced a Youth Voices campaign featuring art in any medium on the Youth Commission Instagram.

RESOLUTION PROMOTING GENDER-INCLUSIVE AND GENDER-NEUTRAL LANGUAGE IN COUNTY LEGISLATION, REGULATIONS, AND RESOLUTIONS

WHEREAS, the County of San Mateo is committed to advancing the rights, protections, dignity, and inclusion of all its residents and employees; and

WHEREAS, the State of California recognized that many transgender, nonbinary, and gender non-conforming individuals are in the state and that there is a necessity for gender inclusivity in state-issued identification documents, legislative drafting guidelines, anti-discrimination laws, and policies related to employment, healthcare, and public facilities; and

WHEREAS, in 2018, the State of California passed a resolution (ACR-260) for the use of gender-neutral pronouns and gender-inclusive language in the drafting of legislation, and for state agencies to participate in efforts to use gender-neutral pronouns and avoid the use of gendered pronouns when drafting policies, regulations, and other guidance; and

WHEREAS, on June 15, 2020, the United States Supreme Court determined that gender identity is a protected category in relation to Title VII of the Civil Rights Act of 1964; and

WHEREAS, it is now a more common and increasingly suggested practice to use gender-neutral and gender-inclusive language in the drafting of legislation regulations, and resolutions where appropriate; and

**WHEREAS,** gender identity is a person's understanding, definition, or experience of their own gender, regardless of sex assigned at birth; and

WHEREAS, misgendering someone (using the wrong pronouns) can have negative impacts on their mental health, self-confidence, and sense of inclusion; and WHEREAS, the use of "they" as a singular pronoun is inclusive of transgender and gender variant individuals.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** that the County shall use gender-inclusive and gender-neutral language in any new legislation, regulations, and resolutions where appropriate to advance equity and inclusion for all individuals and promote a culture of equity and belonging.

**BE IT FURTHER RESOLVED** that the County continues to offer trainings including those relating to LGBTQ+ diversity, gender identity and/or the County's Transgender Policy to promote a respectful and welcoming work environment.

## Lawmakers introduce amendment to repeal Proposition 8

The California Supreme Court ruled same-sex marriage a fundamental right back in 2008.

In the same year of the ruling, critics launched a campaign for Proposition 8 to add an amendment in the constitution that stated only marriage between a man and a woman is recognized in California.

Proposition 8 was approved by 52% of the voters in the 2008 General Election.

Same-sex marriage became legalized in 2013 thanks to a Supreme Court ruling. Now a decade since same-sex marriage was legalized, two state legislators state Sen. Scott Wiener and Assembly member Evan Low, are working to eliminate the language of Prop 8 in the California constitution.

Low sat down with "Inside the Issues" host Alex Cohen to talk about the importance of changing the language in the California constitution to protect same-sex couples.

Low, a member of the California Legislative LGBTQ+ Caucus, dealt with the aftermath of Proposition 8 as an openly gay man.

"After 2008... I went into a downward spiral of depression, self-loathing, substance abuse, thinking about, why is it that fellow Californians hate me so much? Why did a majority of Californians who voted eliminate my right to get married?" Low said.

Low is a co-author with Wiener on Constitutional Amendment 5, or ACA 5, which would make same-sex marriage a basic right in California.

"It's important that we address this and get [Proposition 8] out of our constitution to reflect the inclusive values of everyday Californians," Low said.

Last year, California voters approved Proposition 1, which enshrined reproductive rights and protected access to abortions and contraceptives.

"There is a real fear given the rolling back of Roe v. Wade and the rollback of equal protections for everyday Californians and Americans, that this could be a real threat," Low said.

Two-thirds of the legislature will have to approve ACA 5, and then it will be put on the 2024 General Election Ballot for California voters to make the final decision.

While Low acknowledges that ACA 5 could help galvanize progressives to go out and vote, he also cautions that this campaign will require a lot of effort and money.

"There are many valid and equally justified issues that we should be advocating for and putting our efforts toward," he said. "But again, this has been in our state constitution ever since 2008 and ever since then it's been problematic."

Opinion on same-sex marriage has shifted since 2008. According to a Public Policy Institute of California poll, 61% of likely voters supported same-sex marriage in 2013; and today, 75% of likely voters support same-sex marriage.

"Members of the LGBTQ+ community want to be just like every other individual," Low said. "We want to be in loving, committed relationships recognized by the state and the rights that are afforded to that."

A resolution to propose to the people of the State of California an amendment to the Constitution of the State, relating to rights.

### LEGISLATIVE COUNSEL'S DIGEST

ACA 5, as introduced, Low. Marriage equality.

The California Constitution declares that defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy are inalienable rights, and that a person may not be deprived of life, liberty, or property without due process of law or equal protection of the laws.

This measure would express the intent of the Legislature to amend the Constitution of the State relating to marriage equality.

Vote: 2/3 Appropriation: no Fiscal Committee: no Local Program: no

Resolved by the Assembly, the Senate concurring, That the Legislature of the State of California at its 2023-24 Regular Session commencing on the fifth day of December 2022, two-thirds of the membership of each house concurring, hereby proposes to the people of the State of California, that the Constitution of the State be amended as follows:

It is the intent of the Legislature to amend the Constitution of the State relating to marriage equality.
