- 671 children received services


5084 hotline calls received by CORA (duplicated number)

96% of these clients received a safety plan


197 cases of strangulation noted by CORA, outside of hotline calls

2 cases of suffocation noted by CORA


Type of force of those reporting violence to CORA




ERP Referrals to CORA – 62% successfully contacted post referral

sought by survivors via CORA, Legal Aid Society and San Mateo County Superior Court


2247 individuals requested Legal Services related to DV issues • 298 served by CORA

99 Clients represented in DV proceedings by legal service providers


One agency had a rate of 74% success rate in obtaining restraining orders on behalf of clients

There were 339 restraining orders granted by the court


Gender survivors who reported IPV/survivors who accessed services


Reported incidents Total calls to law enforcement

Total calls to law enforcement in 2020: 1,977

- Total calls with weapons: 400 (20%)
- Number of strangulation cases: 137
 - 42 examined at Keller Center/SMMC (2021)
- Number of suffocation cases: 17
 - 3 examined at Keller Center/SMMC (2021)

Gender (as identified by law enforcement) of suspects in cases referred to the DA's Office for criminal charges:


- Male: 78.2%

Criminal justice data

Total number of IPV cases referred to the DAO for criminal charges: 2,068

- 856 cases criminally charged
- 85 cases under review (as of March 2023)
- 1,127 cases where criminal charges were refused
- 538 cases adjudicated

Data is so unique to each player – not really aggregate but more that we each add a slice to the picture. Leads us to more specific asks rather than a general template

Intersectionality is missing in our data – see languages

Basic starting points – for example communities being perhaps underserved – county specific initiatives to address
