Re: ABAG Executive Board Re-Appointment

Honorable Mayors and Council Members:

I respectfully seek your support for re-appointment to the Association of Bay Area Governments (ABAG) Executive Board. I have served on the Executive Board since December 2020. Before my present appointment, I was the ABAG Board Alternate Member for four years.

My continued interest in serving on ABAG's governing board stems from a commitment to regional transportation and housing planning that includes appropriate local land use, sound economic and housing policies, and a firm respect for the environment.

Over the next two years, ABAG and the Metropolitan Transportation Commission (MTC) will be working with the Bay Area Housing Finance Agency (BAHFA), a vital regional entity our cities need to fund moderate and low-income housing, with the goal of placing a regional housing funding measure on the 2024 ballot. My current nine years as a member and vice chair of ABAG's Regional Planning Committee, my service on ABAG's Housing Methodology Committee where we grappled during an 18-month process to determine our region's RHNA housing allocation methodology, and my three years as an advisory board member to MTC give me the deep experience to engage effectively as your ABAG Executive Board member.

Our twenty diverse cities have numerous varied needs and sometimes divergent concerns. I promise to continue to listen and learn with the rest of you to find solutions and craft positions that address these critical local and regional needs.

I seek your support for reappointment as an Executive Board Member of the Association of Bay Area Governments (ABAG) representing San Mateo County.

As one of the first Filipino Americans elected to the South San Francisco City Council, I understand how important it is to have a seat at the table. As a former aide to Assemblymember Gene Mullin and Congresswoman Jackie Speier, I have over 10 years of legislative experience addressing various regional issues. I currently serve on the Boards of HEART of San Mateo County and the San Mateo County Transportation Authority (TA). I am also President of the Peninsula Division of the League of California Cities and serve on the League's Housing, Community, and Economic Development Policy Committee. Professionally, I work as the San Mateo County Outreach Coordinator for Project Sentinel, a non-profit housing counseling agency. Every day, I speak with both tenants and landlords from all over the County seeking advice on their rights and responsibilities regarding housing issues. The volume of calls I receive at Project Sentinel has increased dramatically because of COVID, which has created unprecedented challenges in housing and the economy.

As a member of ABAG, I have brought to the Board my firsthand experience in tackling regional housing issues. Together with the South San Francisco City Council, we helped our residents by implementing a renter's assistance program weeks before the COVID pandemic began, became the first city in San Mateo County to launch a Guaranteed Basic Income pilot program, and provided grants to support small businesses during the pandemic. South San Francisco is building more housing around transportation hubs such as our new and improved Downtown Caltrain station and the El Camino corridor. These housing developments support our goals of encouraging residents to take alternate modes of transportation, reducing car emissions and traffic, and promoting connectivity and walkability in our neighborhoods.

I will continue to be a representative for all cities in San Mateo County to voice your concerns, questions, and priorities to the entire ABAG Board. I have spoken with many of you about wildfire protection, affordable housing, transportation, the economy, and the environment. Having representation from both

the northern and southern portions of our county will bring a balanced regional perspective to ABAG. I would be honored to serve again as your advocate on ABAG.

I was appointed as an alternate to the Executive Board in January and would like to be reappointed. I now serve on the San Mateo City Council.

I have been on the Board of the San Mateo County Housing Leadership Council since 2001 and I serve on the San Mateo County Housing and Community Development Committee. I have been an advisor to the Metropolitan Transportation Commission (MTC) in different roles since 2003 until January of 2023. I resigned from MTC February 1, 2023 to avoid any conflict of interest.
