Summary of Proposal

Stated Goals

To ensure communications between the San Mateo County Juvenile Justice and Delinquency Prevention Commissions and the San Mateo County Probation Department are consistent and timely and to increase responsiveness.

Formal Communications and Requests

Probation respectfully requests that formal communications between the Commissions and the Probation Department be done through the Chair of the Commissions and Chief of the Probation Department.

Communication and Requests: Subcommittee Chairs and Project Leads
Communication and requests between the Probation Department and the
Commission's subcommittees, and project leads be made through the Chair of the
Subcommittee and or Project Leads and the Assistant Chief of the Probation
Department (Michelle Kozul).

Communication and Requests for Data, Policy, and/or Historical Information Communication and requests between Commissioners and the Probation Department that relate to data, policy, and/or historical information shall be made through the Probation Department's Custodian of Records and Assistant Deputy Chief (Moniay Wade).

Classification and Handling of Requests for Data, Policies, and Historical Records
The San Mateo County Probation Department will classify data, policy, and historical
record requests originating from the San Mateo Juvenile Justice & Delinquency
Prevention Commissions as general public record requests for information, and
process such requests in accordance with the California Public Records Act.

Action Items from January 2024 Meeting:

1. RE: Agenda Item IV. Annual Inspection Report – BSCC:

• s. 1360 Searches – 5 authorization forms for strip searching were reviewed; technical assistance provided re updating language on form; new search authorization form implemented.

ACTION: follow up request to Probation for details on purpose of searches, confirmation of number of searches actually conducted during 2023 inspection year, and for a copy of the newly implemented search authorization form.

• Inspections by JJDPC – regarding institutions operated for dependent children of court, WIC refers to Group Homes, which are now STRTPs. Question arose as to how other CA JJCs interpret the scope of their inspection mandate.

ACTION: follow up with other JJCs to understand the parameters of their inspections of STRTPs. Also consult with counsel?

2. RE: Agenda Item III. Update from Probation:

 Probation reported 170 youth on diversion programs, no petitions filed and youth do not proceed to court.

ACTION: follow up on request to Probation for further details on the substance of the probation diversion programs (how many, how long, what is offered, what are outcomes).
