# INTRODUCTION SUMMARY

Gross earnings for the month ending March 2023 was 2.650%. Gross earnings for the quarter ending March 2023 was 2.504%. Current average maturity of the portfolio is 1.66 years with an average duration of 1.51 years. The current Par Value of the pool is \$7.540 Billion. The largest non-government aggregate position is currently Toronto Dominion Bank NY at 0.98%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2022-23 is 2.00%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

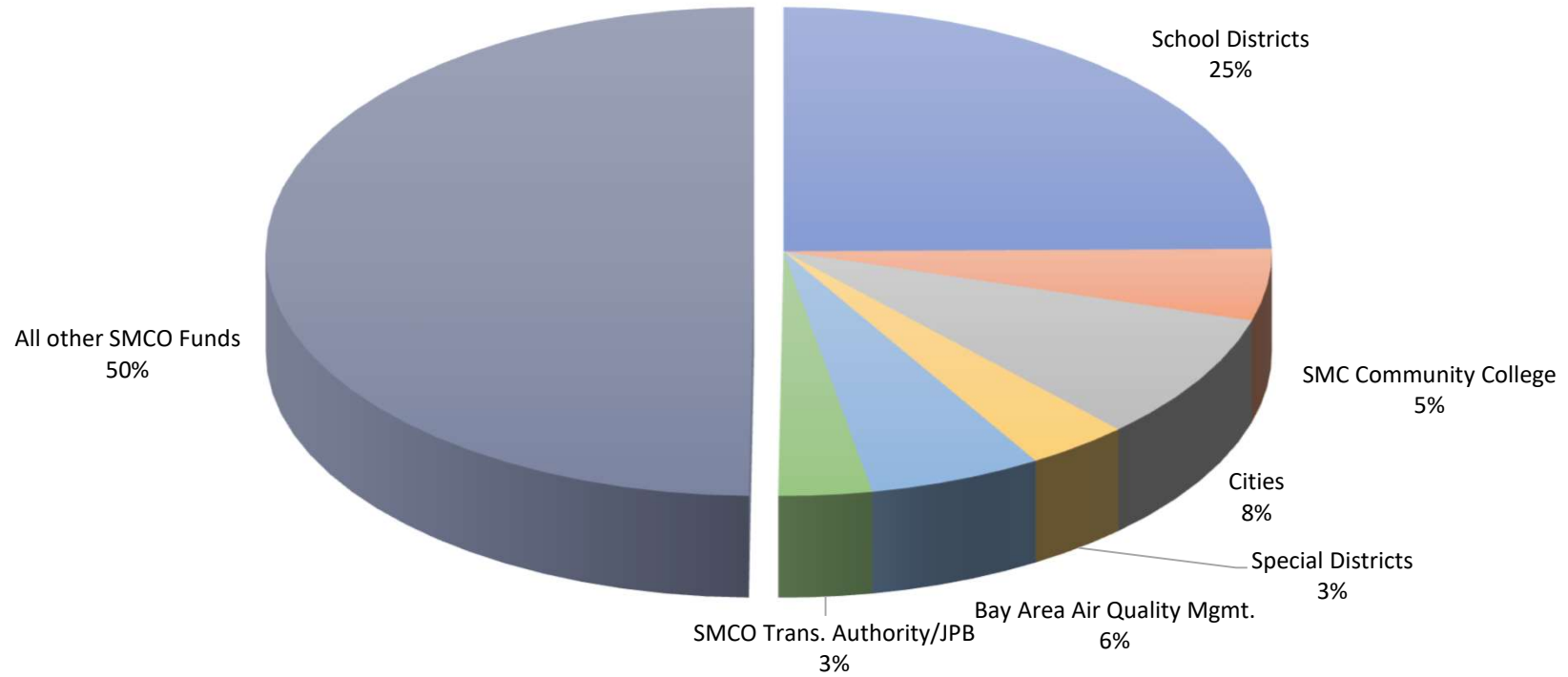
