# INTRODUCTION SUMMARY

The following are the gross pool earnings for fiscal year 2023-2024.

Month End (June-2024)	3.818%
4th Quarter (April-June)	3.927%
Fiscal Year End 2023-2024	3.659%

The gross earnings for FY 2023-24 were \$295 million.

The current average maturity of the portfolio is 1.64 years with an average duration of 1.49 years. The current Par Value of the pool is \$8.494 Billion. The largest non-government aggregate position is currently Cooperative Rabobank at 1.48%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2024-25 is 4.0%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

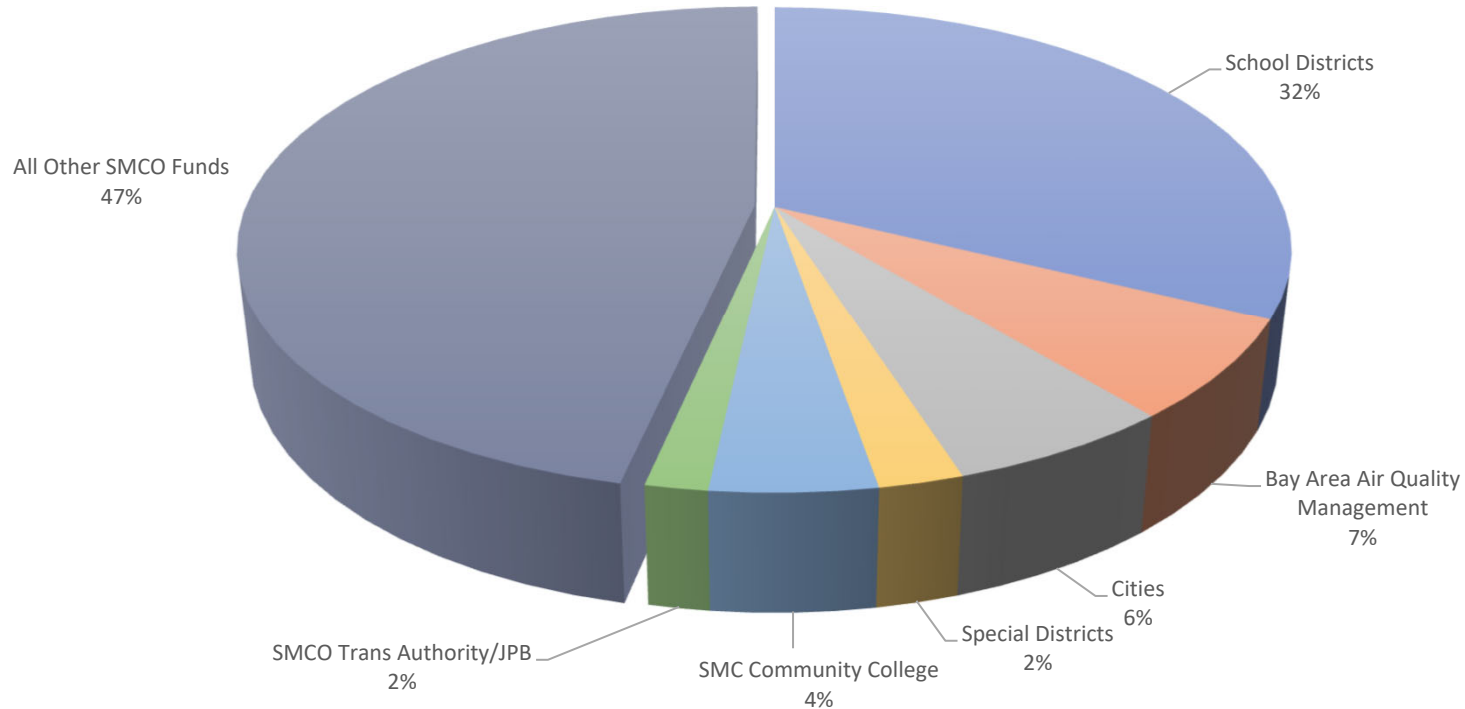

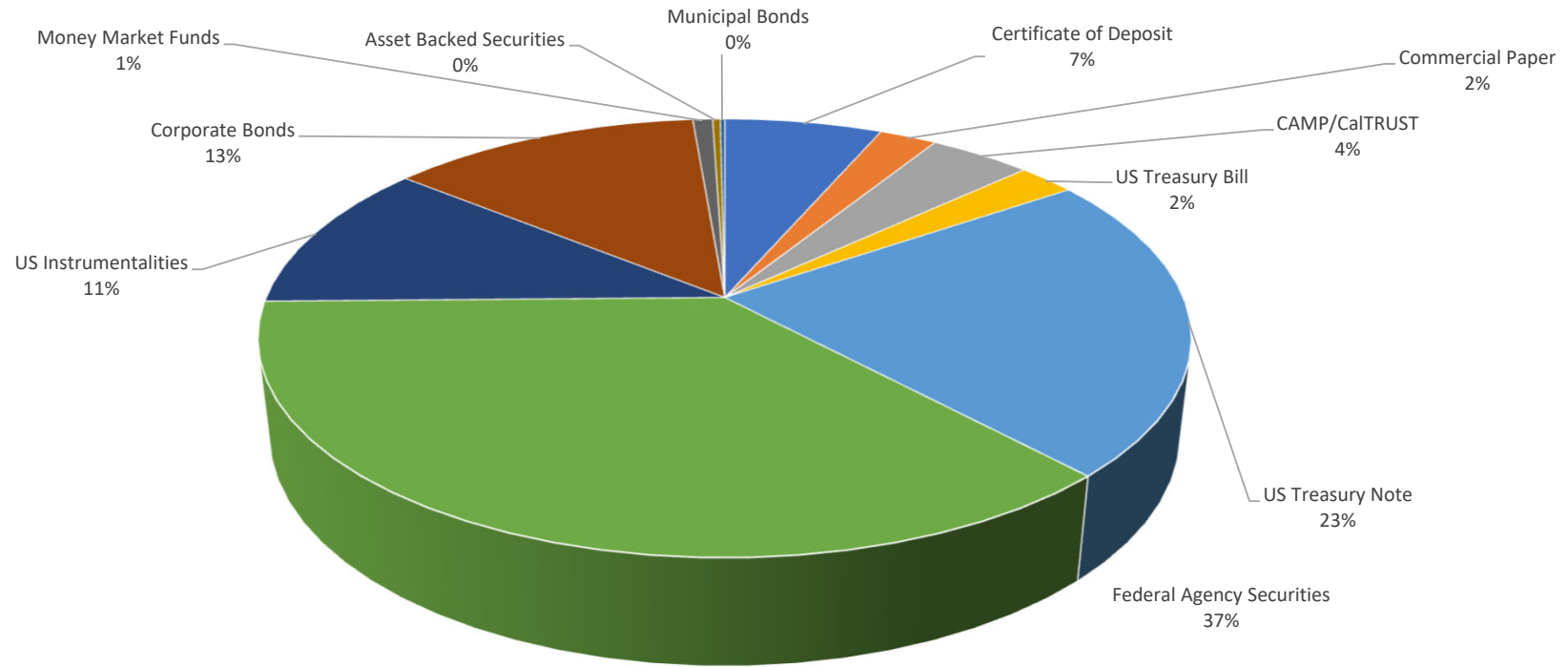
