INTRODUCTION SUMMARY

Gross earnings for the month ending September 30, 2024, was 3.872%. Gross earnings for the quarter ending September 30, 2024, was 3.959%. Current average maturity of the portfolio is 1.82 years with an average duration of 1.66 years. The current Par Value of the pool is \$7.718 Billion. The largest non-government aggregate position is currently Cooperative Rabobank at 1.47%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2024-25 is 3.85%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

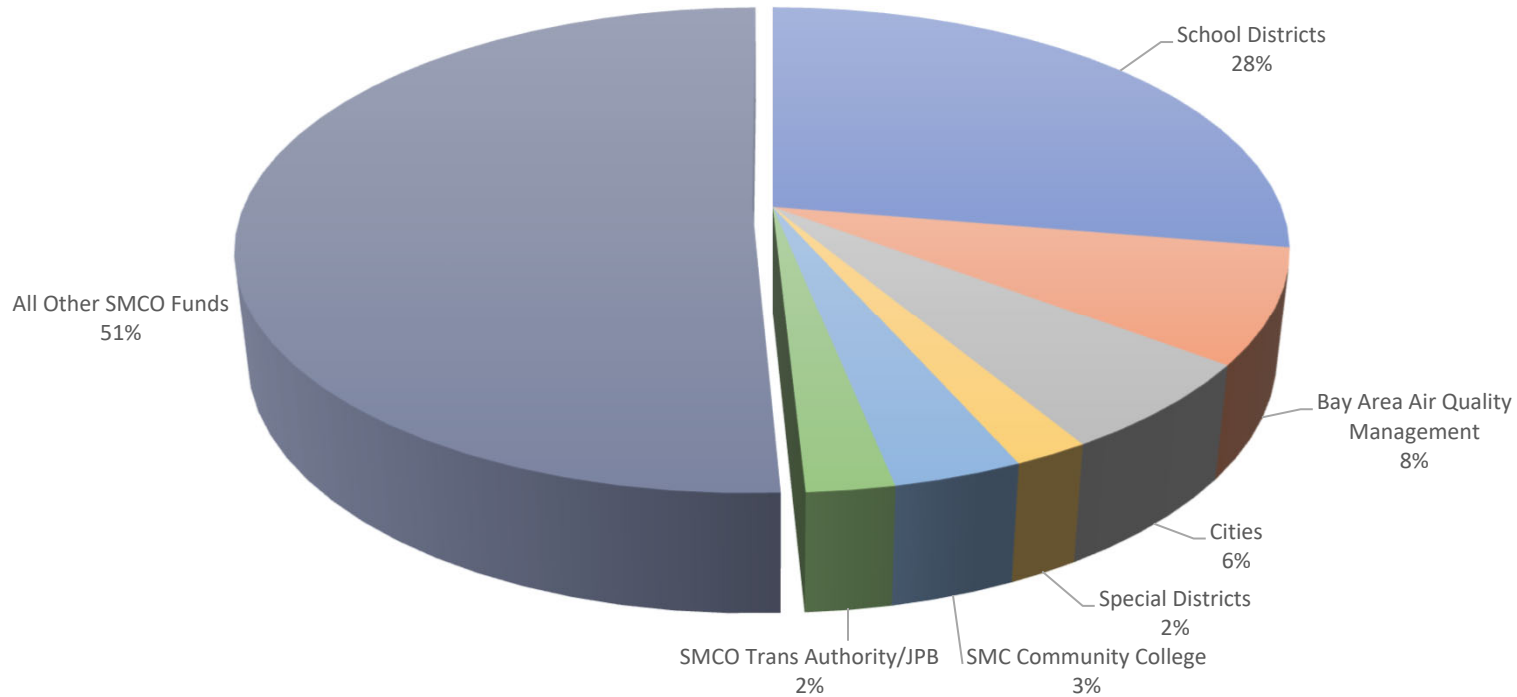

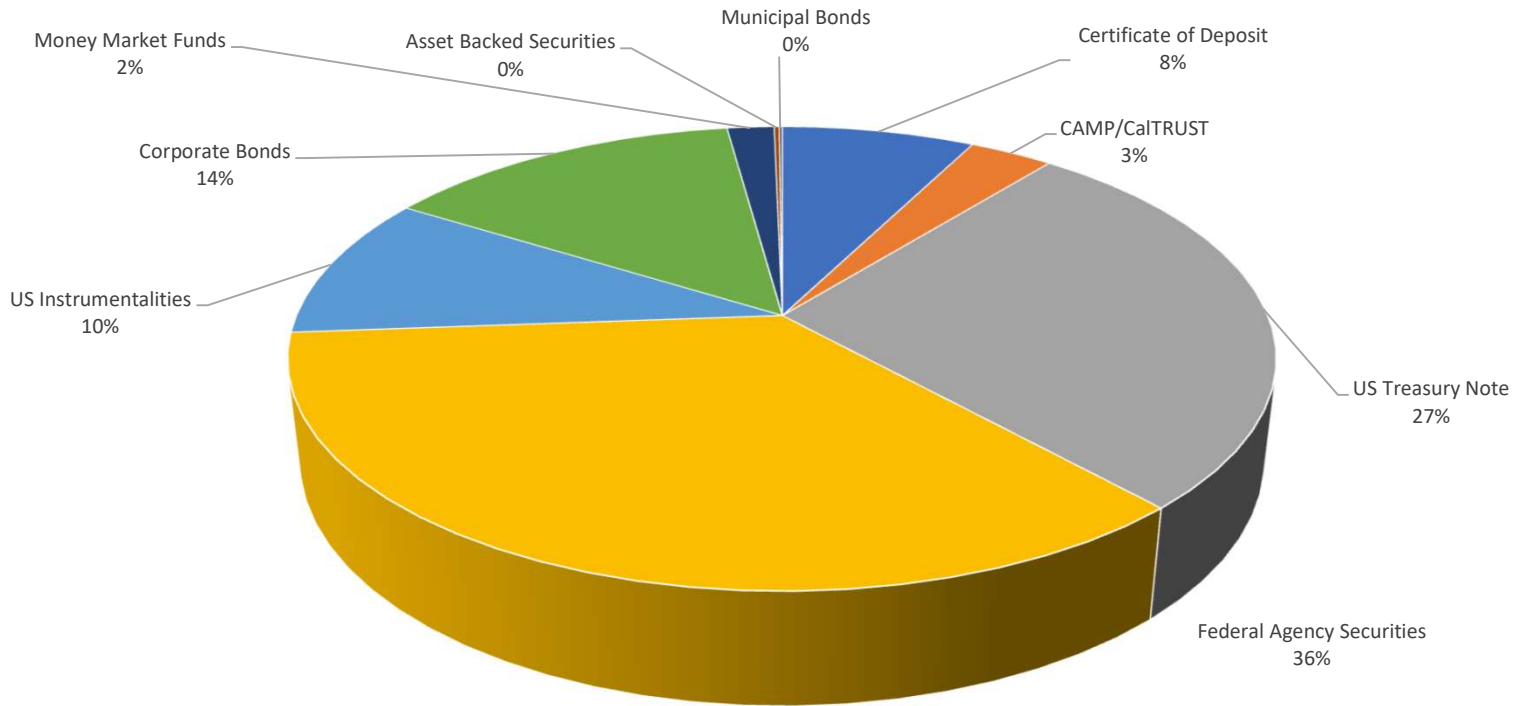
