The Manufactured home and its contents are the sole responsibility of the homeowner. Homeowners shall obtain and maintain insurance for their Unit as required by Section XXII of the Stone Pine Cove's Community's Rules and Regulations.

Homeowners shall obtain and maintain a standard HO-7 manufactured home insurance policy that includes, at minimum, all risk property insurance for the manufactured home at replacement value and liability insurance, naming the County of San Mateo as a loss payee and additional insured, and such other insurance coverage as the County may require.

Homeowner will provide Management with proof of such insurance at move-in and annually, which insurance will name the County of San Mateo as an additional insured and loss payee.
