## **Filoli Spring Garden Season Event Temporary License**

### **Description of Activities:**

Filolis' Spring Garden Season has increased in popularity over the past few years. The garden blooming period draws visitors from around the world to view the garden in bloom. The increased visitation requires us to alter our operations to accommodate the daily visitation and increased rental clients. Filoli's current visitor operations and amenities will continue to be utilized with a few amenities shown on the maps below including a temporary gravel parking lot to accommodate the increase in cars.

### **Event Schedule:**

The Spring Garden Season Event runs from March through Memorial Day. There are a total of 29 days we will utilize the temporary parking lot.

The days we expect to utilize the temporary parking lot include:

Daytime March Weekends: Feb 28, March 1,7,8,14,15,21,22,28,29

Daytime April Weekends: April 4,5,11,12,18,19,25,26

Daytime May Weekends and Memorial Day: May 2,3,9,10,16,17,23,24,25, 30,31

### **Hours of Operation:**

9 am-5:00 pm

Timed Entry tickets every 30 minutes

### **Anticipated Number of Visitors:**

The anticipated numbers will vary throughout the period. Based on previous season visitation, we anticipate a range of 1500-4200 visitors throughout the day. Entry will be moderated utilizing timed ticket entrance.

### **Traffic Control:**

We do not expect a need for traffic control as the anticipated daily visitor count is within our current operational capacity.

### **Food Service:**

Pre-packaged food service from our onsite cafe.

Drinks and bar service at our permitted mobile food trailer

### **Use of Portable Restrooms:**

One portable restroom (water cottage) will be placed by the temporary gravel parking lot.
