# NFO ROADWAY RECONSTRUCTION PROJECTS

## 18th Ave Reconstruction Project

**April 2026-August 2026**

- 18th Avenue – End of road to 775 18th Avenue:
  - Reconstruct the road (approximately 18-foot wide) and install 2-foot wide and 3-foot wide concrete valley gutters on both sides at the edges of the pavement.
- 18th Avenue – 775 18th Avenue to Bay Road:
  - Resurface the existing road and replace concrete curbs, gutters, valley gutters, driveways, and curb ramps at selected locations. Replace sanitary sewer main line and manholes.
- Fair Oaks Avenue – 18th Avenue to Marsh Road:
  - Resurface the existing road and install 2-foot-wide concrete valley gutters on both sides at the edges of the pavement. Conform to existing sidewalk, curb, and gutter.

# BOARD OF SUPERVISORS UPDATES

- On Tuesday, April 21 the Board unanimously passed an ordinance to ban the sale and distribution of kratom and 7-hydroxymitragynine (7-OH) products in unincorporated San Mateo County.
  - These unregulated substances have opioid-like effects and have been linked to addiction and overdose risk
- On February 10, the Board of Supervisors discussed a potential ordinance related to e-bikes and other electric devices in unincorporated San Mateo County. The ordinance did not move forward at that time due to concerns raised by the Board and community.
- Key concerns included:
  - Differences between e-bikes and higher-powered devices (e-motorcycles)
  - Safety, especially for youth
  - Enforcement and consistency across cities
- The item is expected to return with further refinement and community input
