#### **5. PRESENTATION: COMMUNITY ALLIANCE TO REVITALIZE OUR NEIGHBORHOODS (CARON)**

---

**Speakers: Jose Luis Aguirre, Program Coordinator of CARON, Sheriff's Office**

- CARON (Community Alliance to Revitalize Our Neighborhoods) was founded in 1999 during a period of high violence to improve relationships beyond enforcement.
- The program's core mission is to build trust through education, outreach, and partnerships.
- CARON is part of the sheriff's Community Engagement Unit, alongside youth and school-based programs.
- Community Engagement Unit consists of 3 programs:
  - CARON: Works with adults and community groups
  - Sheriff's Activity League (SAL): Works with youth
  - School Resource Officers: Work in schools to support students, staff, and families
- Education is a key strategy, including 6-week community academies covering topics like gangs, drugs, mental health, and laws.
- Family-focused initiatives like the 12-week Parent Project program to improve parent-child relationships and behavior management.
- Outreach includes engaging with day laborers through the Multicultural Institute, attending cultural festivals (e.g., Day of the Dead), and community fairs.
- Mental health education and partnerships (e.g., Behavioral Health services) are part of community safety efforts. Supports programs such as Crisis Intervention Training, Psychiatric Emergency Response Team, and Project Guardian.
- Overall goal: ensure every resident feels seen, heard, and supported.

- Commissioner James shared his experience during his ride along in the Woodside/Portola Valley area:
  - All interactions involved vehicle registration issues.
  - The Deputy was highly knowledgeable about laws, emphasizing the officer's discretion. The deputy appeared to be fair and attentive.
  - Overall experience was educational and positive.
- Commissioner Shirley shared her experience in Half Moon Bay:
  - Assigned deputy was new but enthusiastic.
  - Common calls were welfare checks, majority of activity occurs during the daytime hours.
  - Leadership engagement (meeting with squads and community) has improved morale and created a calmer atmosphere.
  - Housing affordability is a concern for staff; some commute long distances and rely on shared housing.
  - Overall impression was positive and sensed progress within the department.

- Article 6, Section 6.2 - Ad Hoc committees may be established as needed and may not include persons who are **not** members of the Commission.
