INTRODUCTION SUMMARY

Gross earnings for the month ending April 30, 2026 was 4.14%. Current average maturity of the portfolio is 2.64 years with an average duration of 2.36 years. As of the end of the month, the pool is currently on pace to meet the target rate. The current Par Value of the pool is \$10.619 billion. The largest non-government aggregate position is currently Toronto Dominion Bank NY at 0.95%. The portfolio continues to hold no derivative products.

The estimated earnings for FY 2025-26 is 3.75%.

The San Mateo County Pool complies with Government Code Section 53646, which requires the ability to meet its expenditure requirements for the next six months.

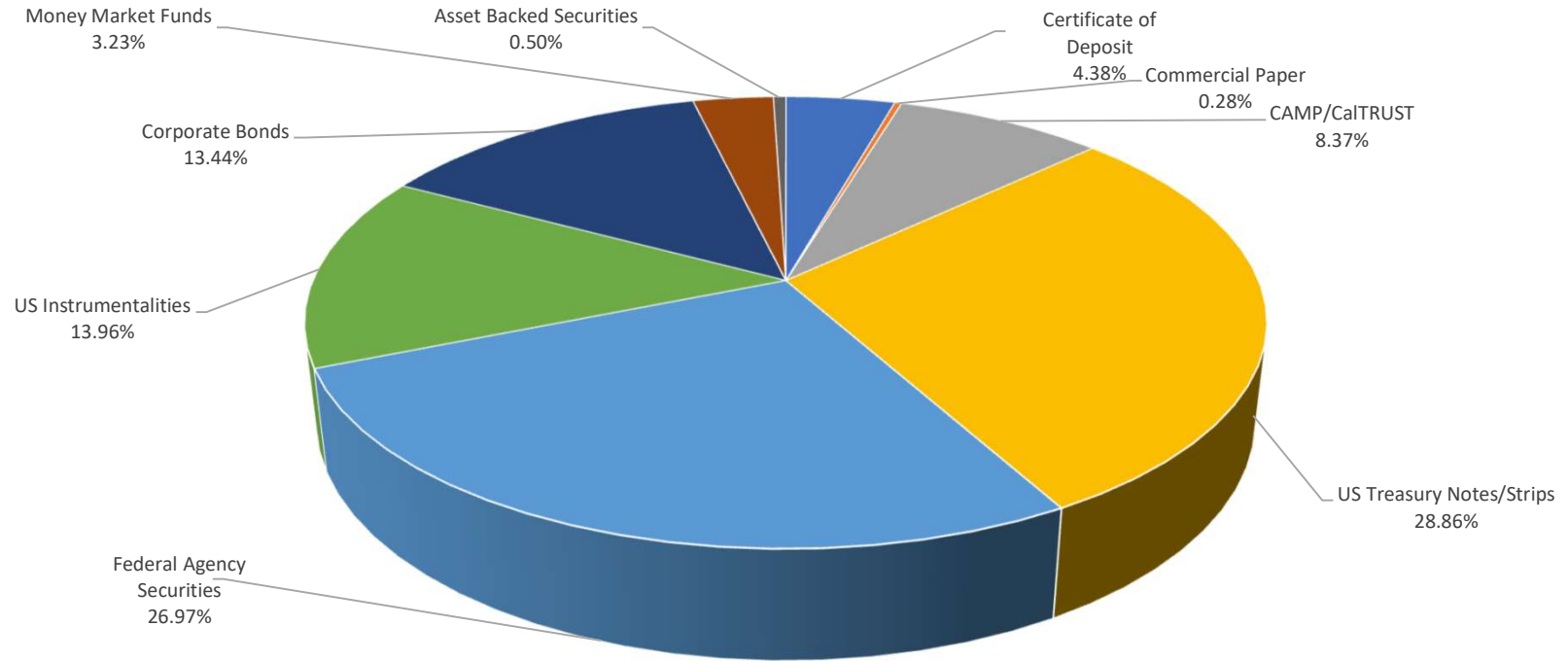

as of April 30, 2026

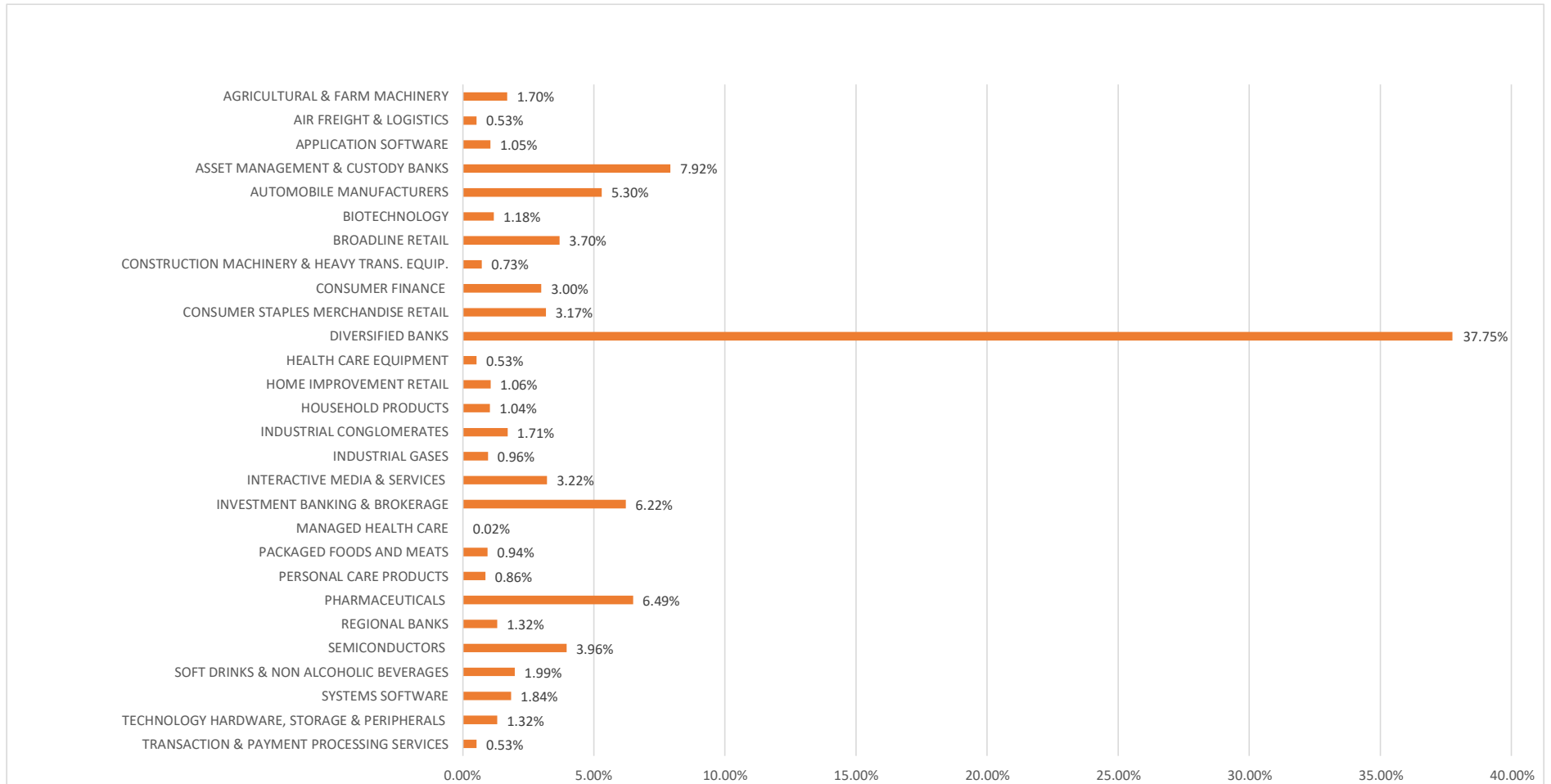
