**RECOMMENDATION:** Approve Local Arts Grants Panelist Pool

#### **BACKGROUND:**

In 2016, a public review of grant applications was conducted for the first time. A panel of three peer reviewers, selected by the Commission Director, reviewed and ranked 29 applications. In 2017, a similar panel of three reviewed and ranked 28 applications. At this point in the Commission's development, it has been suggested that the Commission Director present a pool of potential panelists to the Commission for approval.

The panel that reviews and ranks the applications is comprised of professional artists and arts administrators. Panelists are selected for knowledge and expertise in the various art forms, nonprofit budgeting, program development and evaluation, and in-depth knowledge of Bay Area artists and arts organizations and the current issues that impact their abilities to thrive.

Panelists pre-read, review and rank applications online for the Arts Commission's Local Arts Grants and attend an all-day public review in person. They receive a \$250 stipend for their service.

Three panelists from the following list will be selected to review and rank the 2018 Local Arts Grants applications.

#### Tamara Alvarado

Currently Executive Director of the School of Arts and Culture at the Mexican Heritage Plaza in San Jose. She is a member of the Board of Directors of the Western State Arts Federation and President of the Board of Directors for ACE Charter Schools in the Mayfair neighborhood of San Jose. Ms. Alvarado has been a traditional Aztec dancer for the past 13 years,

#### Jim Fung

Jim Fung is a seasoned performing arts administrator with extensive management and marketing experience in multidisciplinary fields. The Founder and President of Captivate Artists, he has presented local, national and international performers. He is an accomplished pianist and piano teacher and currently serves on the board of California Philharmonic Youth Orchestra. Mr. Fung has previously been a panelist for San Jose Office of Cultural Affairs and Arts Council Silicon Valley.

#### Rhyena Halpern

Oversees the arts and sciences for the City of Palo Alto for the last six years: two museums, three theatres, a public art program, an artist studio program and a maker program. Prior to that Ms. Halpern was the Executive Director of the Sacramento Metropolitan Arts Commission, a local arts agency that makes grants to local artists and arts organizations, provided arts education programming, conducted arts marketing and public art.

#### Linda Johnson

A passionate believer in developing human potential through the arts, Ms. Johnson has grown organizations where community, creativity, and inclusion intersect throughout her career. Prior to joining the Creativity Explored team in 2017, she was Program Manager at Center for Community Arts, a gathering place for arts learning at the City of Walnut Creek, and Executive Director at Streetside Stories, a San Francisco nonprofit that helps young people share stories through the arts.

#### **Barbara Mumby**

As Senior Program Officer at the San Francisco Arts Commission, Ms. Mumby oversees the Cultural Equity grants program, the distribution of approximately six million dollars annually to small and mid-sized arts organizations, individual artists and teaching artists. Prior to joining SFAC, Barbara designed and implemented large-scale early childhood education initiatives and grant programs in both Alameda and Merced counties through their respective First 5 organizations. Ms. Mumby holds master's degrees in Museum Studies and Business Administration, focusing on the international repatriation of Native American cultural property.

#### **Chike Nwoffiah**

Mr. Nwoffiah is an accomplished actor, theater director and filmmaker with over 30 stage and screen credits. He is the founding director of Oriki Theater and founding Artistic Director of the Annual Silicon Valley African Film Festival since 2010. He has previously served on panels for the National Endowment for the Arts, California Arts Council and Fund for Folk Culture.

#### **Denise Pate**

Currently the Cultural Funding Coordinator for the City of Oakland, Cultural Arts and Marketing. She is an experienced speaker, facilitator, grants writer, and has a background in dance. Ms. Pate is an active member of the non-profit arts community and provides consulting services to artists and arts organizations.
