Provider Support



- Flexible hours
- Before/After School, overnight, drop-in
- Often have credentials

CHILDCARE CENTERS

- Lower ratios
- Assessments of quality
- Minimum credentials requirement
- Participates in quality networks
- Structural differences

Licensed Family Child Care Homes

- Provides child care and supervision to 14 or fewer children for less than 24 hours

Inclusion Services (continued)

Enhanced Referral Process

1. Intake Interview

- Identify the needs of the child
- Identify parents' desired criteria
 - eg. location, hours, financial source (private pay or subsidy)

1. Provider Screening

- Search and screen for providers that match the family's needs
- 1. Enhanced Referral
 - Parents are provided with child care provider options identified from the screening

1. Parent Choice

• It is ultimately the parent's decision which provider they choose to utilize

Alternative Payment Program

- Provides child care subsidies to lowincome families that helps them pay for child care services
- The Program is funded and regulated by the State of California Department of Education
- Serves children from 0 to 13 years of age (or up to 22 years old if he/she has a disability and is unable to care for him/herself)

Subsidy Waitlist

 Offers all other families the opportunity to enroll in priority and income order whenever funding becomes available

CalWORKSStage 2

 Offers all other families the opportunity to enroll in priority and income order whenever funding becomes available

CalWORKSStage 3

 Provides extended funding for families currently enrolled who have completed their eligibility to receive CalWORKS Stage 2 child services



Family Eligibility

Subsidy ACCESSList

Assistance with Child Care Eligibility and Support Services

Families are ranked on the waiting list based on their pross monthly income and family size, and has one of the following types of need that qualify for services:

✓ Working

exploitation

✓ Vocational training
✓ Seeking employment
✓ CPS or at-risk of abuse, neglect, or

INCOME ELIGIBILITY

All families, except those who are receiving or who are at risk of receiving Child Protective Services must be at or below the 85th percentile of the State Median Income (SMI) at the time of admission to be approved for subsidized child care.

Services continue until child turns 13 years-old.

Application Process

Enrollment

- Parent/guardian(s) are given instructions on how to apply at 4Cs
- 2. Certification process must be completed prior to receiving services
- Parent/guardian(s) notified by letter that they have been selected in priority order to apply for child care services
- Parent/guardian(s) choice and responsibility in selecting an eligible child care provider from referral list

1. Attend a certification meeting

- 2. Select eligible provider
- 3. Track child care attendance
- 4. Pay Family fees (if applicable)
- 5. Adhere to program rules
