Maintenance Plan Elements

County-wide Mitigation Actions (1 of 3)

Sept. 2021 - 2026

- 1. Maintain a multilingual and culturally appropriate website for the MJLHMP
- 2.Leverage/support/enhance multilingual and culturally appropriate, ongoing, regional public education and awareness programs, such as CERT and ZoneHaven
- 3. Provide technical support and coordination for available grant funding opportunities to the planning partnership



County-wide Mitigation Actions (2 of 3)

Sept. 2021 - 2026

- 4. Develop a **standardized GIS dat**aset for modeling hazards and impacts for regional and jurisdictional assessment purposes
- 5.Develop a multilingual and culturally appropriate business outreach program, in concert with existing business organizations and planning partners, to educate businesses on risk and risk reduction and to identify policies and programs to help businesses become more resilient
- 6.Develop **model policy templates** to assist with coordinated development and implementation of resiliency policies, such as the Safety Elements



County-wide Mitigation Actions (3 of 3)

Beginning August /Sept 2021, when the FEMA BRIC grant process opens

- Increase grant competitiveness by demonstrating regional partnership and leveraging complimentary mitigation actions across the 37-partner plan annexes from the MJLHMP
- Continue to identify regional projects, coordinate grant and other funding development, implementation and administration



Annex Mitigation Actions

- 1. Provide BATool and training to Planning Partners to track mitigation action progress
- 2. Host bi-annual meetings with Partners:
 - Status check-in,
 - Funding and grant application coordination, and
