Review of Rating and Ranking Policy	Focus Strategies and HSA staff provided an overview of the Project Review and Ranking Process policy (approved by the CoC Steering Committee on July 13, 2018), the role of this committee, and aspects of the NOFA that impact scoring of projects.		
Review and Discussion of New Project Scores	The panel members individually scored the 2 new project applications prior to today's meeting based on the 9 factors listed in the Project Review and Ranking Process. The two new applications are a new permanent supportive housing (PSH) bonus project from the Housing Authority and a new DV bonus project from CORA for rapid rehousing (RRH) services.  The panel reviewed and discussed the need for each new project and the project quality as reflected in the application submitted and in relation to the scoring factors. The panel determined that both projects should be included in the Project Priority list. Scores for each new project were finalized and the project ranking determined, taking into consideration how to maximize the likelihood of funding. Both projects were ranked in Tier 2. The CORA project was placed at the bottom of Tier 2 since it is competing for a separate set-aside of DV funding and was rated lower than the other new project application.	HSA will notify applicants of the project ranking and whether or not their projects are included in the 2018 CoC application.  And the CoC Steering Committee will review and approve the ranking	
Review and Discussion of Renewal Project Scores and Re- Allocation	HSA staff presented the scores for the renewals projects, which were calculated based on the 13 objective scoring factors in the Project Review and Ranking Process. The panel asked questions about scores but did not identify any needed adjustments. The panel discussed the placement of renewal projects that have no scores (due to not yet having a year of performance data) and the placement of new project applications. A final rank order of renewals was determined, with the objective of maximizing the amount of funding the CoC will receive and placing the smallest number of projects at risk of de-funding. No renewal projects were re-allocated.
