programs, services, supervision, facility plan, assessment plan, reentry plan, and data and outcome measures.

• Per SB 823, the plan will need to be submitted to the County Managers Office by February 25th and approved at the Board of Supervisors meeting on March 23rd.

Chief Keene discussed the DJJ Realignment plan and stated that the deadlines mentioned will not be the last opportunity to impact what is created, as there will still be time after to finalize goals.

The following were discussed:

- Bringing in more outside partners from community-based organizations to help provide services.
- Connecting the family for reunification and helping the youth be successful in reentry.
- Creating a specialty program may require additional training to run effectively, such as vocational and trauma informed training.
- This will need to be a new program beginning in a secured setting.
- Equity needs to be present in everything we do, and part of our value statements.
- Youth classified as serious mentally ill will depend on a screening process.
- Nick Jasso suggested reaching out to the youth currently at DJJ for input on what works well for them and what does not.
- Jehan Clark shared that the classification system will need to change for this specific population.
- Kate Heister shared that the community college system may be a good partner for services.

III. Roundtable

- DJJ will officially close on June 30, 2023. This target date will help the court processes and decisions that need to be made.
- Noelle or Monica will share the presentation on OneDrive, along with the documents previously sent out.
- The next meeting will be on February 8, 2021.
