## V. New Business

## A. Budget Update

John Keene, Chief Probation Officer, reported there is no budget or funding changes at this time and that the budget remains solid and stable.

• Chief Keene reported that Hong Liu, Deputy Director of Probation, is working on the development of internal scorecards that will assist in evaluating contracted services from our providers.

- Chief Keene talked about the idea of asset mapping in the County to evaluate what services are needed in each city.
- Chief Keene reported the juvenile population in San Mateo County continues to decrease.
- A discussion ensued about the cost of living in San Mateo County and the plummet of juvenile population.

## **B.** Form 700 Requirements

- Chief Keene reported all Form 700's are due from Council Members every year in April.
- Chief Keene reported the new process for filing Form 700's is now done electronically.
- Michelle Mendez, Management Analyst Probation, stated NetFile is the website for Council Members to e-file. Michelle Mendez further stated that e-mails will be sent out to all Council Members who have not yet received an e-mail from NetFile.

## C. Community Based Organization Appointments

Chief Keene spoke regarding adding additional Community Based Organization (CBO) members as permanent positions to the Council. Chief Keene reported that we have one permanent CBO representative, Peter Ehrhorn, Starvista, and he would like to recruit more.

- Chief Keene stated he would like to extend the invite to additional CBO's who might be interested in becoming permanent members of the JJCC.
