V. NEW BUSINESS

A. SB823 – DJJ Realignment Update

Chief Keene discussed the status of SB823 and shared that trailer bill, SB92, has since been passed. SB92 focuses on the procedural gaps that are not fully covered in the original SB823 language and will help provide direction for us, moving forward.

The following were discussed:

- The Office of Youth and Community Restoration (OYCR) will be the new central hub for the evaluation process of our plans in the future. Their roles are not yet fully defined.
- Funding will begin flowing regularly to the counties as of September 1st of every year for the next several years until the funding has expired.
- There may be additional sources of revenue that may come forward regarding other projects, pilots and grants that may be offered.
- Our facility will be serving young adults primarily up to the age of 23, but in certain cases may be extended to the age of 25.
- There will be a review process every 6 months, where the courts will look at individual cases and review rehabilitation plans.
- The county may need services that are not inside the normal scope of what we already have and modifications to existing contracts may be needed.
- The county may need to expand and do some greater outreach to fill in gaps that may be present in the educational space.
- The county will need to find ways to enhance the reentry process and make sure rehabilitation goals are being met. There will always be a working relationship with probation, but the community-based model will be the way to go.
- The county chose not to apply funds for a female specialized program, but we will continue to work with surrounding counties.
- SB823 is targeting the secure track path for funding and the money we receive is currently not transferable to what we already do.
- The courts are currently still working on the baseline dispositional terms for this secure path track.
- Chief Keene envisions having a separate space for youth that need a more specialized programming space, but also a space where youth in the secure track can be around those that are not. We don't want the secure track youth to be fully secluded within our space.

Chief Keene will work with Darlene and Adriana to begin scheduling SB823 subcommittee meetings to discuss each subsection further. Schedules for the targeted meetings will be posted for all to see and members can choose to participate in multiple groups if there is an interest.

B. Budget

Hong Liu reported that there are no significant changes for the next fiscal year.

• JJCPA and JPCF funding sources will have no changes.
