- 3. Both top and bottom edges shall have non-knuckled selvages.
- 4. Fabric shall be hot dip galvanized after weaving to produce a zinc coated bare wire surface, ASTM A392, Class 2.
- 5. The wire in the completed fabric shall stand a tensile strength test of 75,000 pounds per square inch for No. 9 gauge, after galvanizing.
- 6. Fabric for chain link fencing and pedestrian gates shall be hot dip galvanized, except for chain link vehicle gates at trail North and South entrances and chain link fencing on either side of vehicle gate that fronts Skyline Blvd. at the trail North entrance, which shall be black vinyl coated chain link gates shall be black vinyl coated.

B. Posts and Other Accessories

- All posts and other appurtenances shall be galvanized in accordance with ASTM A123.
- 2. The weight of the zinc coating per square foot of actual surface shall average not less than 2.0 ounces, and no individual specimen shall show less than 1.8 ounces.
- 3. Posts, rails, frames, bars, and appurtenances for <u>chain link fencing and pedestrian</u> gates shall be hot dip galvanized, except for chain link vehicle gates at trail North and South entrances and chain link fencing on either side of vehicle gate that fronts Skyline Blvd. at the trail North entrance, which shall be black vinyl coated. ehain link gates shall be black vinyl coated.

C. Line Posts

- 1. Schedule 40 commercial quality pipe having an outside diameter of 2.375 inches and a weight of 3.65 pounds per foot.
- 2. Line posts shall be installed at every 10 feet.

D. Corner, Brace, End and Pull Posts

1. Schedule 40 commercial quality pipe having an outside diameter of 2.875 inches and a weight of 5.79 pounds per foot.

E. Rails and Braces

1. Schedule 40 commercial quality pipe having an outside diameter of 1.660 inches and a weight of 2.270 pounds per foot.

F. Gate Posts:

1. Schedule 40 pipe having an outside diameter of 4.00 inches and a weight of 10.79 pounds per foot.

2. Gate posts shall be equipped with tops to exclude water.

G. Fabric Connections

- 1. Tension bars shall be galvanized 1/4 inch x 3/4 inch steel.
- 2. Pressed steel bands shall be galvanized 11 gauge.
- 3. Ties shall be 9 gauges galvanized steel wire.

H. Gate Frames

 Frames shall be made of Schedule 40 commercial quality pipe having an outside diameter of 1.660 inches and a weight of 2.270 pounds per foot.
