### **Update on County Response to COVID-19**

**Redwood City** – The County of San Mateo continues to work to protect public health and safety in response to the novel coronavirus known as COVID-19.

The County of San Mateo's Emergency Operations Center (EOC) remains open to coordinate countywide response and communications in response to the situation. The EOC's Joint Information Center will provide status reports every Tuesday and Thursday until further notice. Today's report:

### Beaches, Beach Parking Lots Close for Holiday Weekend to Reduce Crowding

This holiday weekend, in an all-out effort to reduce the density of visitors to the San Mateo County coast and as a public health safety measure, the State, County, and cities of <u>Half Moon Bay</u> and <u>Pacifica</u> will close state beach parking areas, city beaches, county beaches and access points to Half Moon Bay State Beach.

<u>San Mateo County Parks</u> will close Tunitas Creek Beach, Fitzgerald Marine Reserve and Devil's Slide Trail.

The closures begin sunrise Friday, July and end 9 a.m. Monday, July 6, and apply to all residents and visitors. San Mateo County Sheriff's deputies will enforce parking regulations and ordinances banning fireworks.

## Sheriff's Office Reports Eight Inmates COVID-19 Positive; Four Recovered

The San Mateo County Sheriff's Office Corrections Unit reports that as of today, eight inmates have tested positive for COVID-19.

The facility adheres to precautionary measures, including universal testing, which helped diagnose the inmates who were asymptomatic. Four inmates remain in the medical housing unit for treatment. Approximately 1.5% of the average inmate population during the pandemic have tested positive for COVID-19.
