County Joins State Monitoring List, County Manager Media Briefing, Testing Locations, and Current COVID-19 Case Count

Redwood City – The County of San Mateo continues to work to protect public health and safety in response to the novel coronavirus known as COVID-19.

The County of San Mateo's Emergency Operations Center (EOC) remains open to coordinate countywide response and communications in response to the situation. The EOC's Joint Information Center will provide status reports every Tuesday and Thursday until further notice. Today's report:

San Mateo County Added to State's COVID-19 Monitoring List

On Wednesday, July 29, 2020, San Mateo County was added to the state's monitoring list, due to an increase in the rate of COVID-19 cases in the county. If the county exceeds the state's case rate threshold for three consecutive days, certain industries and activities will be required to cease operations beginning at 12:01 a.m. Saturday, Aug. 1, unless they can be modified to operate outside or by pick-up.

During the first three days, as long as it remains on the list, the county will be involved in active engagement with the state while the case rate is closely monitored. The county's case rate today, based on a 14-day rolling average, is 110.4 positive cases per 100,000 of population. The state's threshold for inclusion on the monitoring list is a case rate of 100.
