



Legal Criteria for Redistricting

1. Federal Law

Equal population Federal Voting Rights Act

✓ No racial gerrymandering

2. California Law

1. Geographic **contiguity**

- 2. Minimize divisions of neighborhoods & **"communities of interest"**
- 3. Minimize divisions of cities & CDPs
- 4. Easily identifiable boundaries
- 5. Compactness
- Do not "favor or discriminate against a political party"

3. Other Goals

- Preserve core of existing districts
- Minimize changes to election cycles

Do not bypass a nearby population to take in a more distant population

Defining "Communities of Interest"

Under California Elections Code, "community of interest" has a very specific definition in the context of redistricting:



A "community of interest" is a population that shares common social or economic interests that should be included <u>within a single district</u> for purposes of its effective and fair representation.



Definitions of "communities of interest" do **not** include relationships with political parties, incumbents, or political candidates.



What Defines YOUR Community?

Ask yourself...

What brings us together?

- Common social or economic interests
- Shared characteristics or experiences
- Similar issues or impacts of county policies

Where are we?

- Physical boundaries, such as highways or major roads, waterways, hills, etc.
- Areas around parks, schools, or other landmarks

 \rightarrow Would my community be best represented <u>within a single district</u>?

DistrictR Online Mapping Tool


DistrictR is a simple online "paint brush" tool that allows you to "paint" your neighborhood, your comr account or login is required to access the tool.
