Re: Utility Box Mural Project – Fifth Avenue and Waverly Avenue

Recommendation:

Approve the recommendation from the North Fair Oaks Public Art Workgroup for the mural design on the County-owned utility box located at the intersection of Fifth Avenue and Waverly Avenue.

Background:

The North Fair Oaks Community Plan envisions a vibrant, safe and healthy community that includes public art highlighting the local history and cultural background of the community. A Call for Artists was released on September 28, 2015 inviting local San Mateo County artists to submit mural designs for the County owned utility box located at Fifth Avenue and Waverly Avenue. Installation of the art will be completed by February 2016, and a \$500 stipend will be awarded for completion of the box.

Discussion:

The selected artist, a past resident of North Fair Oaks, has extensive art experience including creating designs for Hallmark Cards, Electronic Arts and KFOG event billboards. The Public Art Workgroup considered the designs based on the following criteria:

- Artistic excellence, innovation and originality
- Experience to complete the project within the required time frame
- Incorporation of local youth and student artists
- o Preference will be given to artists who live or work in North Fair Oaks

Based on the majority vote of the Public Art Workgroup, the design on page three was recommended for the utility box located at the intersection of Fifth Avenue and Waverly Avenue. This design was chosen based on the originality of the design, celebration of uniqueness and diversity as well as extensive experience of the artist. The artist's statement of interest in addition to examples of past work are included on pages four and five.



Fiscal Impact:

An amount of \$500 from Measure A funds were allocated for the utility box mural project in North Fair Oaks. The funds are available in the 2015/2016 budget and will be encumbered for the following fiscal year. The cost for each box covers the artists' time as well as all material costs.

Artist Statement


