## HIGHLIGHTS FROM THE REPORTING PERIOD:

## **Dine and Dialogue**

This summer, NFO Forward hosted a summer dialogue series with the purpose of bringing community members together to enjoy a casual dinner, learn about a featured topic and discuss with each other their hopes and ideas for the future of North Fair Oaks.

Our third dialogue took place on August 12 at the Fair Oaks Health Center and the discussion topic was Healthy Habits. The event resulted in great conversations and ideas that were shared among all 15 attendees.

The NFO Forward Team put together a summary of the entire Dine & Dialogue series, which contains notes from each discussion group and feedback from the evaluation forms. The summary will be posted on the NFO Forward website along with links to each presentation.

## **NFO Public Art Workgroup**

The Public Art Workgroup has completed a variety of projects this summer, including three Utility Box Murals and the installation of four North Fair Oaks Entrance Signs. The workgroup is planning a community gathering in early October to celebrate the implementation of these recent projects. Moving forward, the workgroup is interested in exploring locations murals and other art projects in North Fair Oaks.

## Local Business Sustainability Plan

The NFO Forward team has made numerous outreach efforts to local businesses along the Middlefield Road corridor to identify their concerns and needs regarding the upcoming Middlefield Road Redesign. Next steps include the development of a local business advisory workgroup that will continue to provide input as the Business Sustainability Plan is developed. We are currently in the research phase of this process and we will provide an update soon.

#### **North Fair Oaks Zoning Changes**

In addition to the public hearing on July 23, 2015, part of the North Fair Oaks Community Council meeting, another opportunity for public input on the proposed zoning changes along Middlefield Road between 1<sup>st</sup> Avenue and 8<sup>th</sup> Avenue was held on Wednesday, August 5<sup>th</sup> at the Fair Oaks Community Center. ## **Reimagine Flood Park Update**

The San Mateo Parks Department hosted two community meetings on the redesign of Flood Park (located on Bay Road in Menlo Park). There was a great turn out at each meeting, one hosted at Menlo Park's Community Center and the other one at the Fair Oaks Community Center. After obtaining community input at the meetings and conducting an online survey to learn about priorities of the park users, the design consultant has prepared three design alternatives that are ready to be presented back to the community.

The third community meeting will be held on Tuesday, September 1, 2015 at the Fair Oaks Community Center from 7pm-9m. Simultaneous translation and childcare will be provided. Please join us and provide your input on the proposed design alternatives.

## **Other Outreach Efforts and Events**

NFO Forward continues to actively engage the North Fair Oaks Community. The team enjoyed participating in the 14<sup>th</sup> Annual North Fair Oaks Community Festival on Sunday, August 16, 2015.
