NFO Public Art Workgroup

The Public Art Workgroup will be rolling out a variety of projects this summer. Project updates include:

- North Fair Oaks Entrance Signs
 - o Installation is scheduled for completion by August 2015.
- Utility Box Mural Project
 - Middlefield and 5th Ave complete
 - o Middlefield and 8th Ave complete
 - o 5th Ave and Semicircular is in progress; expected completion no later than Aug 5

Local Business Sustainability Plan

On July 1, 2015, 11 business owners and property owners along the Middlefield Road corridor met to review and comment on the results of the survey they completed earlier this year. The

results of the survey process identified the following priority issues of concern: parking, customer attraction, impact of the construction schedule, a need for timely communication and maintaining access to open businesses. Respondents were also interested in the following issues: increasing energy efficiency, better trash collection and façade or storefront improvements. Next steps include the development of a local business advisory workgroup that will continue to provide input as the Local Business Sustainability Plan is developed.

North Fair Oaks Zoning Changes - Phase 1

In addition to the public hearing before the July 23, 2015 North Fair Oaks Community Council meeting, there will be an another opportunity for public input on the proposed zoning changes along Middlefield Road between 1st Avenue and 8th Avenue before they are considered by the North Fair Oaks Community Council:

The San Mateo County Planning and Building Department will give a presentation on the proposed zoning changes as well as the timeline for implementation. Attendees will have a chance to ask questions and comment on the changes. There will also be opportunities to get involved in future zoning changes within North Fair Oaks.

Reimagine Flood Park Update

The San Mateo Parks Department has hosted two community meetings on the redesign of Flood Park (located on Bay Road in Menlo Park). There was a great turn out to both meetings, one hosted at Menlo Park's Community Center and the other one at the Fair Oaks Community Center. After obtaining input at the meetings and conducting an online survey to learn about everyone's priorities, the data collected is ready to be presented to the community.

The third community meeting will be held on Tuesday September 1 at the Fair Oaks Community Center from 7pm-9m. Simultaneous translation and childcare will be provided. Please join us and provide your input on the design alternatives.
