

### SAN MATEO COUNTY STEERING COMMITTEE

#### **BACKGROUND**

The Census Bureau is constitutionally mandated to count every person residing in the United States every ten years. The decennial census is the cornerstone of our democracy, ensuring equitable political representation and fair allocation of resources at all levels of government. Ensuring an accurate count of all county residents in the Census 2020 is essential.

Unfortunately, there are several new challenges facing the upcoming census, including widening distrust in the federal government and concerns regarding data privacy. It is expected that self-response to the Census 2020 will be significantly lower than in previous years, yet the Bureau will have less funding per household than in 2010 for outreach and follow up.

The County has already taken steps to prepare for Census 2020, setting a strong foundation for a complete count. This includes ensuring that all county residences are included in U.S. Census Bureau Master Address File, building partnerships for census outreach coordination, and advocating for state and federal decisions that can help ensure a complete count. In January 2019, the County will form a Complete Count Committee with diverse stakeholders to promote collaboration and coordination for Census 2020 outreach.

#### **PURPOSE AND ROLE**

The County Census Steering Committee is convened by the County Managers Office to provide guidance, coordination, and support for census efforts across the county.

The committee will meet every other month to:

- Review Complete Count Committee plans and progress
- Provide guidance for communication strategy and messaging
- Identify opportunities to support outreach through county/district/city programs and channels

#### **MEMBERSHIP**

Chair: Iliana Rodriguez, Deputy County Manager

Committee members include:

- Representatives of elected officials in each county district
- Leadership from County departments/offices that serve hard to reach populations
- City managers from jurisdictions that have high concentrations of hard to count populations
