Economic Empowerment Team: Financial Wellness Subcommittee

Update:

- Presentation on **Financial Wellness**:
 - Financial Wellness helps women build wealth. Building wealth is essential for all women to do throughout their work lives. It has gained popularity and many employers embrace it as a benefit.
 - Women have different financial needs compared to men and respond differently to services and tools that may be helpful to them.
 - 62% of women report fair to extreme stress over finances compared to
 53% of men: survey for "Financial Health Network"
 - Women have been negatively affected by the pandemic and this will have permanent consequences. NYT reports that a 35 year old woman making \$80K/yr who leaves the workforce for 5 years will lose more than \$197K in retirement benefits.
- Recent meetings with both the San Mateo County Benefits Department and the San Mateo Credit Union. Both are very supportive and actively involved in promoting financial wellness for their constituencies. The SMCU financial literacy program for high school students was recognized nationally last year by the industry.
- The Financial Wellness Subcommittee will continue to explore effective, best practice FW programs in both large and small businesses and organizations and identify barriers to women's wealth-building. We will report back to the CSW of our progress.



Update: Human Trafficking Task Force

- Presentation by Ruth Silver Taube- Legal Services Chair, South Bay Coalition to End Human Trafficking – today's focus is on labor trafficking
 - Labor trafficking includes finding of force, fraud, or coercion
 - Cases tend to be quite complex need assistance from experienced advocates
 - Almost always includes wage theft
 - Federal labor laws and state labor laws apply
 - How a case is charged or filed changes the possible recovery can get more than just wage restitution, including compensatory and punitive damages
 - Lawyers and judges need educated on what labor trafficking is
 - Less is known about labor trafficking than sex
 - Does not have to include smuggling
 - Statutes of limitations apply so timing is important
 - Ruth does many trainings including for law enforcement and bus drivers (both VTA in San Jose and MTA in San Francisco)
- Presentation by Sue Williams, Advocate- Justice At Last
 - Bay Area legal services provider exclusively serving human trafficking victims
 - Provide safety and emotional support to trafficking victims
 - Assists trafficking victims in defining and accessing their definition of justice this may or may not include the criminal justice system
 - Trauma informed and survivor driven
 - JAL has four attorneys and one advocate
 - Population served 26% male, 74% female; 54%sex, 43% labor, 3% both
 - Have a robust intake to screen for broad list of possible needs
 - Assist with crime victims' rights, post-conviction vacatur (expunging criminal record, family law (e.g. protective orders), immigration relief
 - Office of Labor Standards Enforcement (OLSE) provides a free Advice Line for businesses and workers seeking information or assistance with labor standards compliance or workplace issues - 1-866-870-7725

 - Training session is on the Sherriff's YouTube channel
