#### 4. New Business

## **Update on AB109 Offender Population:**

- John Keene, Chief Probation Officer, reported on Q2 for the Post-Release Community and Mandatory Supervision Update. He reported 72 new supervisees for the quarter—26% lived out-of-county. Approximately 15% of the Q2 violations were for property crimes.
- Chief Keene stated that the Probation Department has supervised 1365 supervisees since the implementation of Realignment (AB109) in October 2011—more than half of the supervisees successfully completed supervision under Realignment.
- Chief Keene reported that 33% of the violations were technical violations (i.e. failure to report, substance abuse, etc.).
- Greg Munks, Sheriff, reported on Q2 AB109 In-Custody Monthly Report. He reported that the Maguire Jail population is at 729; the women's jail population is 88; the medium security facility population is 28; the Sheriff's Work Program population is 137. Sheriff Munks commented that most of the population decreases are a result of Prop 47 as opposed to Realignment, which is holding steady.
- Sheriff Munks reported 1170(h) split sentences at 72%; straight sentences 28%. AB109 inmates represent 15% of the total in-custody population.
- Sheriff Munks announced that the new Maple Street Correctional Center ribbon cutting will be held on March 1.
- Sheriff Munks talked about the San Mateo County Quarterly Realignment Bulletin dated February 10, 2016. He briefly spoke to the challenges tracking crime trends (i.e. vehicle theft, burglary, etc.) and attributing those trends to an exact cause.
- Jennifer Valencia, HSA Employment Services, reported an increase of 66% in new intakes for Q2. She stated that Service Connect for the first time accepted 6 new Parolees into the program.
- Ms. Valencia reported that 550 Jobs! had 14 clients employed out of 18 participants in Q2. She stated that the average wage earned was \$12.36/hour.
- Ms. Valencia commented that services continue to be utilized mostly for housing—approximately 50% reported being homeless.
- Scott Gruendl, Assistant Director BHRS, talked about the updated BHRS Service Connect Dashboard Q2 Summary handout. Mr. Gruendl spoke to the department's data points and highlighted services and participation for Q1 vs. Q2—total services for Q2 were 5,697.

## **Discussion on the Impact of Proposition 47 on San Mateo County**

- Chief Keene talked about some of the trends developing in Probation around Proposition 47 (Prop 47). He reported 61 cases were terminated and subsequently removed from all levels of supervision as a part of Prop 47.
- Chief Keene reported 630 cases on general probation—approximately 535 distinctive cases. He provided information on the Specialty Courts and indicated that a few of the terminated cases were still on supervised probation because of other cases.
