In order to be consistent with our County-approved Berth License Agreement, we are changing the way that we apply late payment fees. Per the Berth License Agreement, fees are due the 10th, and are late if not received by the 25th of the month. Our previous policy has been to waive late fees for payments that are postmarked by the 25th. Starting in November we will enforce the terms of the Berth License Agreement and apply late fees to all balances where payment is not received either in the Redwood City office or at the marina office by the 25th of the month (or if the 25th falls on a weekend or holiday the first business day thereafter). Please be sure checks are mailed in time to arrive by the 25th. Remember you can always call the office and pay by credit card or set up automatic ACH deductions from your checking account.
