Hi Tim,

The only information that is not uploaded to the P&B Website are Building permit records and DPW records and correspondence which did not include me, which are requested here. All other items requested are online.

Regarding Item 5, the condition numbers she references do not seem to line up with what she is asking for, such as:

- Condition No. 2 has to do with the recordation of the Final Map which has long been completed and isnt mentioned anywhere else in the letter.
- Condition 43 and 44 and Building Dept and PG&E conditions. DPW conditions start in Section E but start from Condition No. 45.
