## Hi Camille,

I conducted the pre-site inspection at Lot 11 today, and the site looks great. NexGen has addressed my action items from the previous two pre-site inspections. All tree protection fencing has been installed per the civil plans and the tree protection plan. In addition, the silt fence has been installed around the limits of grading, and it has been properly keyed in.

As we discussed last week, at the initiation of ground disturbance onsite a stabilized construction entrance will need to be constructed and maintained throughout the duration of the construction activities per the erosion control plan. However, construction equipment will be required to construct the entrance, therefore it should be part of the initial construction activities onsite. I mentioned this requirement to Bob today.
