This morning a pre-construction clearance survey was conducted at Lot 11 for California red-legged frogs in order to fulfill the requirements of Mitigation Measure BIO-2d. The survey areas included the upland areas of Lot 11 and the riparian areas outside of the chain link fence and orange plastic fencing. There were no frog species detected within the disturbance boundary or near the adjacent creek during the survey.

Along with the survey, an environmental awareness training was conducted for all crew members who are working on site today to inform them of the potential special status species that they could encounter while working, and how to proceed if they do.
