To summarize what we discussed this afternoon, Neil and I have both observed erosion on Lots 9/10 due to water running down Cobblehill Road and onto the project site during rain events. It is our understanding that NexGen has not received approval from DPW to connect the DI's with the onsite stormwater diversion system at this time, and therefore water is flowing onsite from the street and creating erosion issues. Once stormwater is able to enter the DI's, then stormwater will be diverted into the stormwater system to avoid causing significant erosion onsite. It would be ideal to connect the DI's prior to the next rain event, or as soon as possible to avoid further erosion onsite.
