I am constrained to bring it to your kind attention that Camille - Don Folsom nexus appears to be acting as a weapon of our discrimination and harassment.

As one such example, please see attached the "Construction Site Inspection Report" and the attached photograph of Don Folsom from yesterday Oct 27, 2021.

1. Where is the "Construction Site"? My property is not a construction site. How did he even get the idea that my property is a "construction site"?
2. Please see the attached photo, the check dam is right behind Don Folsom in the photo. Don Folsom's "Construction Site Inspection Report" claims there is no check dam. From the back of Don Folsom's inspection report - "Check Dam - a small barrier constructed of rock...."
3. In section 9, Don Folsom claims there is "no Mulch". Don Folsom is standing on Mulch.
4. Please see attached our attorney's letter sent to Anne and Richard Martin who have in apparent desperation, co-conspired to weaponize various public agencies and public officials for harassment and discrimination against us. Please see attached the co-conspirators.
5. Further, please notice Don Folsom trespassing on our property.
6. Of particular note is that in spite of the major storm of Saturday-Sunday, which uprooted so many trees, our more than 38 fiber rolls, check dam and other measures, stood their ground and were an effective erosion control measure. Please see the attached photo.

Yet, in his comments Don Folsom seems to mention that we should hit the wooden spikes tearing into the fiber rolls - on expert advice and from past experience, doing so splits open the fiber rolls making them less effective. Further the new more expensive degradable fiber rolls do not lend themselves to this.

I, my family and our neighbors would greatly appreciate your kind and immediate intervention in ending this targeted discrimination and harassment, by using your department as the vehicle.
