Hi Bob.

It was nice to see you at Highland Estates yesterday. Thank you for meeting with Tay and having her come out to document the status of the woodrat houses on Lots 9 and 10. As we discussed, please address the following action items ASAP. We have a large rainstorm in the forecast for Sunday and Monday.

- 1. Please repair the silt fence on Lot 11, which is protecting the riparian zone along the southern side of the property. Please also ensure that any drainage from the site is being directed to upland areas, and not being directed into the sensitive riparian zone.
- 2. Please sweep Cowpens Way and Cobblehill Rod as the street in both locations is overloaded with sediment and is causing trackout into the neighborhood.
- 3. Please re-install tree protection fencing on Lot 9. The oak trees on the southern side of the site have been hit by equipment and need to be protected from any further damage.
- 4. Please re-install silt fence that was removed on the downslope side of Lot 9 prior to the rain event this weekend.
