

NOTICE OF PUBLIC HEARING

Proposed Sphere of Influence Amendment and Reorganization of Granada Sanitary District into the Granada Community Services District

NOTICE IS HEREBY GIVEN that the Executive Officer of the San Mateo Local Agency Formation Commission (LAFCo) will hold a public hearing to receive written protest regarding the following LAFCo reorganization proposal.

Short Form Designation: LAFCo File No 13-05—Proposed Sphere of Influence Amendment and Reorganization of Granada Sanitary District into the Granada Community Services District which was submitted to LAFCo by resolution of application by the Granada Sanitary District.

Exterior Boundaries of the Subject Territory: The exterior boundaries include the current exterior boundaries of the Granada Sanitary District, less rural undeveloped lands to be detached as shown on the map in the District's application. The map may be viewed in the District's application at the LAFCo Office, 455 County Center, Redwood City, CA or Granada Sanitary District Office, 504 Alhambra Avenue, 3rd Floor, El Granada, CA or on the District's website.

Type of Change of Organization: Sphere amendment detaching rural lands not included in the District's garbage franchise and the reorganization of the Granada Sanitary District forming the Granada Community Services District for the continued provision of sanitary sewer service and garbage collection and addition of park and recreation service in the unincorporated territory of the District. LAFCo's Resolution 1176 approving the reorganization with conditions can be reviewed at the LAFCo office and on the LAFCo website at www.sanmateolafco.org.

Stated Reason for the Reorganization: To add park and recreation service in the unincorporated area of the District (in addition to sanitary sewer district-wide and garbage collection in unincorporated district territory) to meet the demonstrated need for community and neighborhood parks and recreation. The District's application including map of the boundaries of the District may be viewed at the LAFCo Office, the Granada Sanitary District Office or Granada Sanitary District website.

Hearing Date, Time and Place: Wednesday, February 19, 2014 at 7:00 p.m. in the Auditorium of El Granada Elementary School, 400 Santiago Street, El Granada, El Granada, CA.

Written protests against this reorganization may be filed by registered voters residing within District boundaries. Written protests can be mailed to San Mateo LAFCo, 455 County Center, Redwood City, CA 94063 **or** delivered to the LAFCo Executive Officer at the protest hearing. Written protests may be submitted using the form below or by submitting handwritten protest. Each protest must be filed no later than the conclusion of the protest hearing to be valid. Each person signing must affix in addition to signature, his/her name, the date upon which he/she signs the protest and residence address. All protests without a date or bearing a date prior to publication of this notice shall be disregarded for purpose of measuring value of protest.

Value of protests received will be determined in accordance with Gov. Code Section 57075.
