Subject: Appointment of Public Member for Vacant Term Ending May 2018

The term for Public Member that is set to expire May 2018 became vacant upon the retirement of Commissioner Linda Craig in January. Section 56334 of the Cortese-Knox-Hertzberg (CKH) Act sets forth that any vacancy in the membership of the Commission shall be filled for the unexpired term by appointment by the body which originally appointed the member whose office has become vacant. Chair Cosgrove and Commissioners Horsley and O'Neill served on the Public Member Recruitment Committee to interview applicants for the public member position.

Pursuant to LAFCo policy, staff distributed and posted a notice of the vacancy dated January 21 for submittal of applications by March 21. Notices were distributed by mail to cities, special districts, libraries, the City Selection Committee, and the County.

The Commission received seven applications in response to the release and notice. After conducting interviews with the applicants and careful consideration of their applications, the Committee enthusiastically recommends Ann Draper for the regular public member position based on her broad professional experience as a city and county planner; serving as member and chair of numerous civic organizations; and her understanding of the LAFCo process from county, city, and special district perspectives.

Government Code Sections 56325 (d) requires an affirmative vote from the majority of the Commission, including an affirmative vote from at least one each of the County, City, and Special District members to appoint a public member.
